**THE OLDHAM - SADDLEWORTH AREA CONSOLIDATION ORDER
EXPERIMENTAL PROHIBITION OF WAITING ORDER 2018**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 22nd January 2018 shall come into operation on 29th January 2018 and may be cited as the Oldham – Saddleworth Area Consolidation Order Experimental Prohibition of Waiting Order 2018 and will remain in force until 28th July 2019

2. The Oldham – Saddleworth Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the First Schedule below are deleted from the Principal Order at Part 1 Schedule 1 and replaced with the waiting restrictions detailed in the Second Schedule below for the period of this Order
3. This Order shall be construed as one with the Principal Order.



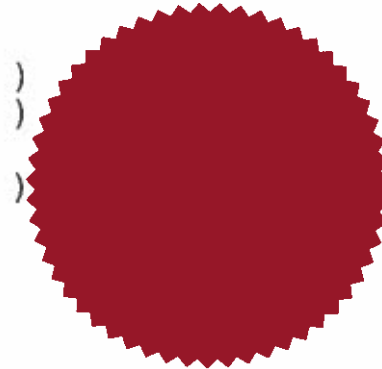
