

OLDHAM BOROUGH COUNCIL**THE OLDHAM – WINTERBOTTOM STREET
PROHIBITION OF STOPPING ORDER 2017**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order made on 24th February 2017 shall come into operation on 27th February 2017 and may be cited as the Oldham – Winterbottom Street Prohibition of Stopping Order 2017
2. Save as provided in Article 3 no person shall, except upon the direction or with the permission of a police constable in uniform or of a civil enforcement officer, cause or permit any vehicle to stop during the times specified in the Schedule below in any of the sides or lengths of roads specified in the Schedule to this Order.
3. Nothing in Article 2 shall render it unlawful to cause or permit any vehicle to stop in any of the lengths of road referred to therein for so long as may be necessary to enable the vehicle, if it cannot conveniently be used for such purpose in any other length of road, to be used in connection with any of the following operations, namely:-
 - (i) building or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the length of roads or any other adjacent length of road;
 - (iv) the laying, erection, alteration or repair in, or in land adjacent to, the length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus as defined in Schedule 2 to the Telecommunications Act 1984;
 - (v) use in the service of a local authority in pursuance of statutory powers or duties;
 - (vi) use of the vehicle for fire brigade, ambulance or police purposes.
4. The prohibition and restriction imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
5. The Oldham – Winterbottom Street Prohibition of Stopping Order 2016 made on 1st September 2016 which came into operation on 5th September 2016 is hereby revoked in its entirety

Lengths of Road

Winterbottom Street

(west and north west side)

From a point 66 metres south of Middleton Road for a distance of 25.56 metres in a southerly and south westerly direction
