**20 MPH SPEED LIMIT ORDER 2023**

The Oldham Borough Council, in exercise of their power under section 84(1) and (2) of the Road Traffic Regulation Act 1984, and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act hereby make the following Order:-

1. This Order made on 5<sup>th</sup> May 2023 may be cited as the Oldham – Canon Dolan Way Chadderton 20 MPH Speed Limit Order 2023 and shall come into force on 12<sup>th</sup> May 2023
2. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the lengths of roads specified in the Schedule to this Order.

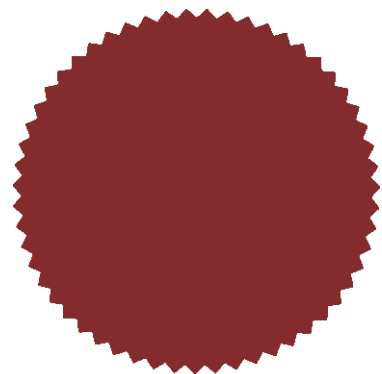

**THE OLDHAM - CHADDERTON AREA CONSOLIDATION ORDER PROHIBITION OF WAITING  
AMENDMENT No 70 ORDER 2023**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 5<sup>th</sup> May 2023 shall come into operation on 12<sup>th</sup> May 2023 and may be cited as the Oldham – Chadderton Area Consolidation Order Prohibition of Waiting Amendment No 70 Order 2023
2. The Oldham – Chadderton Area Consolidation Order 2003 the "Principal Order" shall have effect as though the waiting restrictions detailed in the Schedule below are included in the Principal Order at Part 1 Schedule 1 from the date of this Order
3. This Order shall be construed as one with the Principal Order.

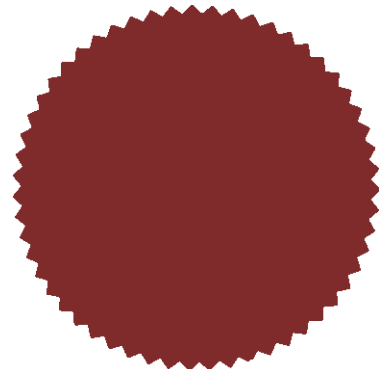
