**ROAD TRAFFIC REGULATION ACT 1984**

**THE OLDHAM SADDLEWORTH AREA CONSOLIDATION ORDER PROHIBITION OF WAITING AMENDMENT No 54 ORDER 2017**

The Oldham Borough Council in exercise of its powers under sections 1(1), 2(1), 2(2), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 7<sup>th</sup> August 2017 shall come into operation on 14<sup>th</sup> August 2017 and may be cited as The Oldham - Saddleworth Area Consolidation Order Prohibition of Waiting Amendment No 54 Order 2017.
2. The Oldham Saddleworth Area Consolidation Order 2003 (as amended) ("the Principal Order") shall have effect as though the waiting restrictions detailed in the Schedule below are inserted in the Principal Order at Part 1 Schedule 1 from the date hereof.
3. This Order shall be construed as one with the Principal Order.

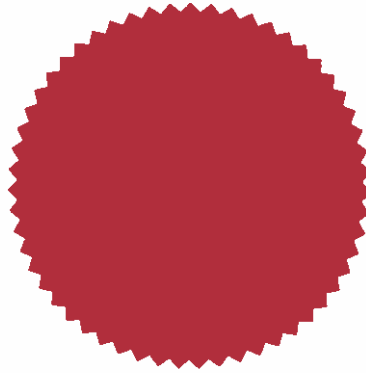
