

OLDHAM BOROUGH COUNCIL**ROAD TRAFFIC REGULATION ACT 1984****THE OLDHAM (CROMPTON AREA) CONSOLIDATION ORDER PROHIBITION OF WAITING
AMENDMENT No 52 ORDER 2017**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 24th April 2017 shall come into operation on 28th April 2017 and may be cited as the Oldham Borough Council (Crompton Area) Consolidation Order Prohibition of Waiting Amendment No 52 Order 2017.
2. The Oldham (Crompton Area) Consolidation Order 2003 (as amended) ("the Principal Order") shall have effect as though the items detailed in the First, Second and Third Schedules below are deleted from the Principal Order at Part I Schedule 1, Part I Schedule 2 and Part II Schedule 9 respectively and the provisions detailed in the Fourth Schedule below are inserted in the Principal Order at Part I Schedule I from the date hereof.
3. This Order shall be construed as one with the Principal Order.

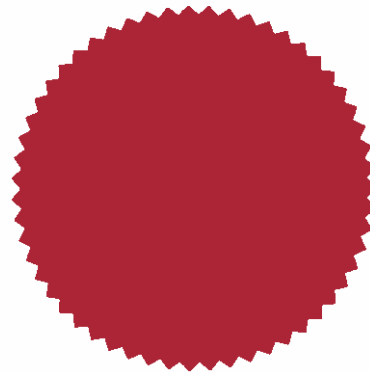
