**THE OLDHAM - OLDHAM AREA CONSOLIDATION ORDER PROHIBITION OF WAITING & LOADING AMENDMENT No 184 ORDER 2019**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 7<sup>th</sup> May 2019 shall come into operation on 14<sup>th</sup> May 2019 and may be cited as the Oldham – Oldham Area Consolidation Order Prohibition of Waiting & Loading Amendment No 184 Order 2019
2. The Oldham – Oldham Area Consolidation Order 2003 (the "Principal Order") shall have effect as though the waiting and loading restrictions detailed in the Schedule below are included in the Principal Order at Part 1 Schedule 1 from the date of this Order
3. This Order shall be construed as one with the Principal Order.

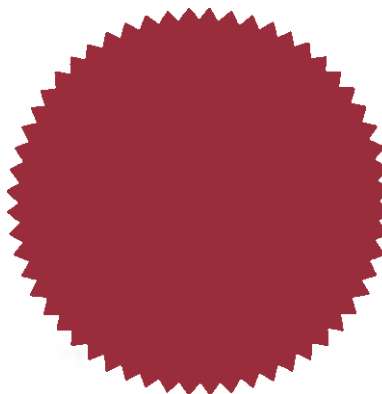
