**THE OLDHAM AREA CONSOLIDATION ORDER PROHIBITION OF
WAITING AMENDMENT ORDER 2020**

Cambridge Street/Durham Street junction

The Oldham Borough Council on 30th January 2020 made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to prohibit waiting at all times on both sides of Cambridge Street 10 metres north west of its junction with Durham Street to 10 metres south east of its junction with Durham Street and on both sides of Durham Street 10 metres north east of Cambridge Street to 10 metres south west of Cambridge Street.

The Order will come into operation on 6th February 2020

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.

**THE OLDHAM - OLDHAM AREA CONSOLIDATION ORDER PROHIBITION OF WAITING
AMENDMENT No 190 ORDER 2020**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 30th January 2020 shall come into operation on 6th February 2020 and may be cited as the Oldham – Oldham Area Consolidation Order Prohibition of Waiting Amendment No 190 Order 2020
2. The Oldham – Oldham Area Consolidation Order 2003 the "Principal Order" shall have effect as though the waiting restrictions detailed in the Schedule below are included in the Principal Order at Part 1 Schedule 1 from the date of this Order
3. This Order shall be construed as one with the Principal Order.
