**THE OLDHAM - OLDHAM AREA CONSOLIDATION ORDER PROHIBITION OF WAITING
AMENDMENT No 192 ORDER 2020**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 31st January 2020 shall come into operation on 6th February 2020 and may be cited as the Oldham – Oldham Area Consolidation Order Prohibition of Waiting Amendment No 192 Order 2020
2. The Oldham – Oldham Area Consolidation Order 2003 the "Principal Order" shall have effect as though the waiting restrictions detailed in the First Schedule below are deleted from the Principal Order at Part 1 Schedule 1 and the Permitted Parking detailed in the Second Schedule below are deleted from the Principal Order at Part 1 Schedule II and the waiting restrictions detailed in the Third Schedule below are included in the Principal Order at Part I Schedule I from the date of this Order
3. This Order shall be construed as one with the Principal Order.

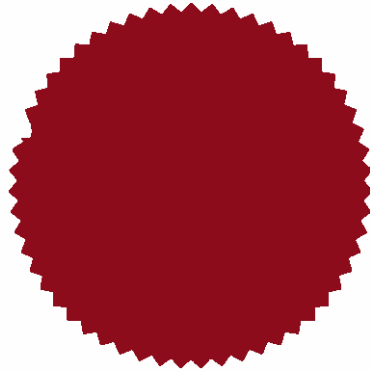
