THE OLDHAM - OLDHAM AREA CONSOLIDATION ORDER PROHIBITION OF WAITING & PARKING PLACES (ON STREET) AMENDMENT No 217 ORDER 2022

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

- This Order made on 12th October 2022 shall come into operation on 19th October 2022 and may be cited as the Oldham – Oldham Area Consolidation Order Prohibition of Waiting & Parking Places (On Street) Amendment No 217 Order 2022
- 2. The which Order is hereinafter referred to as the "Principal Order" shall have effect as though the waiting restrictions detailed in the First Schedule below are deleted from the Principal Order at Part 1 Schedule 1 and replaced with the waiting restrictions detailed in the Second Schedule below and the Parking Places (On Street) detailed in the Third Schedule below are deleted from the Principal Order at Part II Schedule 6 from the date of this Order
- 3. This Order shall be construed as one with the Principal Order.
