THE OLDHAM - ROYTON AREA CONSOLIDATION ORDER PROHIBITION OF WAITING & PARKING PLACES (SPECIFIED CLASSES OF VEHICLE) <u>AMENDMENT No 53 ORDER 2021</u>

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

- This Order made on 2nd September 2021 shall come into operation on 9th September 2021 and may be cited as the Oldham – Royton Area Consolidation Order Prohibition of Waiting & Parking Places (Specified Classes of Vehicle) Amendment No 53 Order 2021
- 2. The Oldham Royton Area Consolidation Order 2003 the "Principal Order" shall have effect as though the waiting restrictions detailed in the First Schedule below are deleted from the Principal Order at Part 1 Schedule 1 and replaced with the waiting restrictions detailed in the Second Schedule below and the Parking Places (Specified Classes of Vehicle) detailed in the Third Schedule Below are deleted from Part II Schedule 4 of the Principal Order and replaced with the Parking Places (Specified Classes of Vehicle) detailed in the Fourth Schedule below from the date of this Order.
- 3. The Oldham Royton Area Consolidation Order Prohibition of Waiting & Parking Places (Specified Classes of Vehicle) Amendment No 52 Order 2020 is revoked in its entirety from the date of this Order
- 4. This Order shall be construed as one with the Principal Order.
