THE OLDHAM – ROYTON AREA CONSOLIDATION ORDER PARKING PLACES (SPECIFIED CLASSES OF VEHICLE) (DISABLED BAYS) AMENDMENT No 59 ORDER 2024

- 3. This Order shall be construed as one with the Principal Order.
