**THE OLDHAM – CROMPTON AREA CONSOLIDATION ORDER PROHIBITION OF WAITING &
PERMITTED PARKING AMENDMENT No 67 ORDER 2022**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 12th October 2022 shall come into operation on 19th October 2022 and may be cited as the Oldham – Crompton Area Consolidation Order Prohibition of Waiting & Permitted Parking Amendment No 67 Order 2022
2. The Oldham – Crompton Area Consolidation Order 2003 the "Principal Order" shall have effect as though the waiting restrictions detailed in the First Schedule below are deleted from the Principal Order at Part I Schedule I and replaced with the waiting restrictions detailed in the Second Schedule below and the Permitted Parking detailed in the Third Schedule below is included in the Principal Order at Part I Schedule II from the date of this Order
3. This Order shall be construed as one with the Principal Order.
