THE OLDHAM - SADDLEWORTH AREA CONSOLIDATION ORDER PROHIBITION OF WAITING & LOADING AMENDMENT No 74 ORDER 2022

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

- This Order made on 4th February 2022 shall come into operation on 11th February 2022 and may be cited as the Oldham – Saddleworth Area Consolidation Order Prohibition of Waiting and Loading Amendment No 74 Order 2022
- 2. The Oldham Saddleworth Area Consolidation Order 2003 the "Principal Order" shall have effect as though the waiting and loading restrictions detailed in the Schedule below are included in the Principal Order at Part 1 Schedule 1 from the date of this Order
- 3. The Oldham Saddleworth Area Consolidation Order Prohibition of Waiting Amendment No 66 Order 2019 is hereby revoked in its entirety
- 4. This Order shall be construed as one with the Principal Order.


