**THE OLDHAM – SADDLEWORTH AREA CONSOLIDATION ORDER PARKING PLACES  
(SPECIFIED CLASSES OF VEHICLE) (DISABLED BAYS) AMENDMENT No 86 ORDER 2024**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, (“the Act”) and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 2<sup>nd</sup> February 2024 shall come into operation on 9<sup>th</sup> February 2024 and may be cited as the Oldham – Saddleworth Area Consolidation Order Parking Places (Specified Classes of Vehicle) (Disabled Bays) Amendment No 86 Order 2024
2. The Oldham – Saddleworth Area Consolidation Order 2003 the “Principal Order” shall have effect as though the Parking Places (Specified Classes of Vehicle) detailed in the First Schedule below are deleted from the Principal Order at Part II Schedule 4 and the Parking Places (Specified Classes of Vehicle) detailed in the Second Schedule below are included in the Principal Order at Part II Schedule 4 from the date of this Order
3. This Order shall be construed as one with the Principal Order.
