# THE OLDHAM - OLDHAM AREA CONSOLIDATION ORDER PROHIBITION OF WAITING AMENDMENT No 172 ORDER 2018

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- This Order made on 21<sup>st</sup> May 2018 shall come into operation on 28th May 2018 and may be cited as the Oldham – Oldham Area Consolidation Order Prohibition of Waiting Amendment No 172 Order 2018
- 2. The Oldham Oldham Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the Schedule below are included in the Principal Order at Part I Schedule I from the date of this Order
- 3. This Order shall be construed as one with the Principal Order.
