& BUST STOP CLEARWAY NOTICE

Godson Street Oldham

The Oldham Borough Council on 31st January 2020 made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to prohibit waiting at all times on Godson Street west side 10 metres north of Magdala Street to 20 metres north of Coldhurst Street and on the east side commencing opposite the northern kerbline of Magdala Street to 10 metres north west of Lower Edge Avenue

The Order will come into operation on 6th February 2020

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.

BUS STOP CLEARWAY

The Oldham Borough Council give notice under the Road Traffic Regulation Act 1984 as amended by the Traffic Signs Regulations and General Directions 2002 that 24 hour Bus Stop Clearways will be introduced on:-

Godson Street - west side from a point 23 metres north of its junction with Coldhurst Street for a distance of 24 metres in a northerly direction

Godson Street – east side from a point 90 metres south of its junction with Crompton Street for a distance of 45 metres in a southerly direction

The bus stop clearway will become operative on 28th February 2020 and the Bus Stop Clearways will conform and will be signed in accordance with the Traffic Signs Regulations and General Direction 2002.
