**THE OLDHAM – OLDHAM AREA CONSOLIDATION ORDER CAR PARK
AMENDMENT No 204 ORDER 2021**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, (“the Act”) and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 19th March 2021 shall come into operation on 26th March 2021 and may be cited as the Oldham – Oldham Area Consolidation Order Car Park Amendment No 204 Order 2021
2. The Oldham – Oldham Area Consolidation Order 2003 the “Principal Order” shall have effect as though the Parking Places (Off Street) detailed in the First Schedule below are deleted from Part II Schedule 5a of the Principal Order and the Parking Places (Off Street) detailed in the Second Schedule below are included in the Principal Order at Part II Schedule 5c from the date of this Order.
3. This Order shall be construed as one with the Principal Order.
