

ROAD TRAFFIC REGULATION ACT 1984

OXFORDSHIRE COUNTY COUNCIL (WEST OXFORDSHIRE DISTRICT) (DISABLED PERSONS' PARKING PLACES) (AMENDMENT) ORDER 2007

The Oxfordshire County Council ("the Council") in exercise of their powers contained in Section 1, 2 and 4 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order:

1. This Order shall come into operation on the 26th March 2007 and may be cited as the Oxfordshire County Council (West Oxfordshire District) (Disabled Persons' Parking Places) (Amendment) Order 2007.
2.
 - (1) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
 - (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
3. The Oxfordshire County Council (West Oxfordshire District) (Disabled Persons' Parking Places) Order 2006 is amended to the extent and in the manner specified to the Schedule to this Order

Schedule 1 is deleted and replaced by the following

"SCHEDULE 1 DISABLED PERSONS' PARKING PLACES (24 hour parking places without Time Limit)"

1	Bladon	Park Close	West side; from a point 31.5 metres north of the northern kerbline of Park Lane, northwards for a distance of 6.6 metres. Outside No's 1 & 2 Park Close.
2	Burford	High Street	a) West side; from a point 11 metres north of the centre line of Sheep Street, northwards for a distance of 29 metres.
			b) East side; from a point 13 metres north of the centre line of Witney Street, northwards for a distance of 10 metres.
3		Witney Street	South-west side; from a point 15 metres south-east of the north-west property boundary of No 44 Witney Street, south-eastwards for a distance of 6.6 metres. Outside No 48 Witney Street.
4	Charlbury	Pooles Lane	South-west side; from a point 26 metres south-east of the south-eastern kerbline of Brown's Lane, south-eastwards for a distance of 6.6 metres.
5	Chipping Norton	Church Street	South side; from a point 17 metres south-east of the centre line of Whitehouse Lane, south-eastwards for a distance of 6.6 metres. Outside Wesley Manse.
6		Cornish Road	North side; from a point 168 metres south-west of the south-western kerbline of Hailey Road, south-westwards for a distance of 6.6 metres. Outside No 39 Cornish Road.
7		Diston's Lane	West side; from the southern property boundary of No 22 Diston's Lane, northwards to the northern property boundary of No 24 Diston's Lane, for a distance of 10.8 metres.
8		Hailey Avenue	North-west side; from a point 27 metres north-east of the centre line of its junction with Hill Close, north-eastwards for a distance of 6.6 metres. Outside No 27 Hailey Avenue.
9		Hailey Road	South-west side; from a point 12 metres south-east of the centreline of the junction with Hailey Avenue, south-eastwards for a distance of 6.6 metres. Outside No 20 Hailey Road, in the lay-by.
10	Eynsham	High Street	North side; from the common property boundary of No's 17 & 19 High Street, south-eastwards for a distance of 6.6 metres. Outside No 19 High Street.
11	Long Hanborough	Churchill Way	South-east side; from a point 12.3 metres south-west of the south-western kerbline of Main Road, south-westwards for a distance of 13.2 metres. Outside Long Hanborough Surgery.
