# OXFORDSHIRE COUNTY COUNCIL (WEST OXFORDSHIRE DISTRICT) (DISABLED PERSONS PARKING PLACES) (AMENDMENT No.6) ORDER 2013

The Oxfordshire County Council ("the Council") in exercise of its powers contained in Sections 1, 2, 4, 32, 35 and 45 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

- 1. This Order may be cited as the Oxfordshire County Council (West Oxfordshire District) (Disabled Persons Parking Places) (Amendment No.6) Order 2013 and shall come into operation on the eighth day of July 2013.
- 2. (1) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
  - (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
  - (3) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.
- 3. The Oxfordshire County Council (West Oxfordshire District) (Disabled Persons Parking Places) Order 2006, as amended by the Oxfordshire County Council (West Oxfordshire District) (Disabled Persons Parking Places) (Amendment) Order 2007, the Oxfordshire County Council (West Oxfordshire District) (Disabled Persons Parking Places) (Amendment No.2) Order 2009, the Oxfordshire County Council (West Oxfordshire District) (Disabled Persons Parking Places) (Amendment No.3) Order 2011, the Oxfordshire County Council (West Oxfordshire) (Disabled Persons Parking Places) (Amendment No.4) Order 2012, and the Oxfordshire County Council (West Oxfordshire) (Disabled Persons Parking Places) (Amendment No.5) Order 2012 ("the 2006 Order"), is amended in the manner and to the extent specified in the Schedule to this Order.

### SCHEDULE

Amendments to "the 2006 Order".

1.

In article 2 – Definitions, the following is deleted and replaced:

" disabled persons parking place" means a length of road specified in Schedules 1 and 1A to this Order, being located in any of the towns or parishes specified in Schedule 2 to this Order, and authorised to be used as a parking place for disabled persons' vehicles (and otherwise) as provided by Article 4 of this Order;"

2.

Articles 4, 5 and 6 are deleted and replaced as follows:

- "4. (1) Each of the lengths of road specified in Schedules 1 and 1A to this Order is authorised to be used, subject to the following provisions of this Part of this Order, as a parking place for the classes of vehicles specified in Article 5 only.
  - (2) No vehicle other than of a class specified in Article 5 shall park at any time in the lengths of road specified in Schedules 1 and 1A.

### Time Restricted Waiting

- 4A. (1) Save as provided in Article 12, no person shall, except upon the direction or with the permission of a Traffic Warden, the Council or a police constable in uniform, cause or permit any Disabled Persons Vehicle to wait in any of the lengths of road specified in Schedule 1A of this order:
  - (a) for a period longer than 3 hours; or
  - (b) if a period of less than 1 hour has elapsed since the termination during the Prescribed Hours of the last period of parking (if any) of the vehicle in the same Disabled Persons Parking Place
  - (2) Where a vehicle, having been left in a Disabled Persons Parking Place remains there at the beginning of the Prescribed Hours, then the vehicle will be

- treated as if it had arrived in the Disabled Persons Parking Place at the beginning of the Prescribed Hours.
- 5. Each parking place specified in Schedules 1 and 1A may be used for the leaving of the following classes of vehicle:
  - (1) a disabled persons vehicle;
  - (2) a vehicle being used for any purpose specified in Article 11 of this Order.

# Position in Which a Vehicle May Stand

6. The driver of a vehicle of a class specified in Article 5 shall not permit it to wait in a disabled persons parking place unless it is standing in position in single line with the whole nearside or offside of the vehicle adjacent to the kerb unless otherwise specified in Schedules 1 and 1A."

3.

A new Schedule 1A is inserted as follows:

### "SCHEDULE 1A

#### **DISABLED PERSONS' PARKING PLACES**

## (24 hour parking places with 3-hour Time Limit)

1	Witney	High Street	East side; from the common property boundary between Nos. 16 and 18 High Street southwards to a point 4 metres north of the northern flank wall of Nos. 2-8 High Street
		High Street	East side; from the northern flank wall of Nos. 2 to 8 High Street southwards for a distance of 6.6 metres
		Market Square	Main route (West side); from a point 23 metres south of the southern flank wall of No. 1 High Street southwards for a distance of 6.6 metres."
