OXFORDSHIRE COUNTY COUNCIL (VARIOUS ROADS – WEST OXFORDSHIRE) (PROHIBITION AND RESTRICTION OF WAITING AND PERMITTED PARKING) (VARIATION No.3) ORDER 2014

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1, 2, 4, and 32 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order:

- 1. This Order may be cited as the Oxfordshire County Council (Various Roads West Oxfordshire) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.3) Order 2014 and shall come into force on the third day of March 2014.
- 2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
 - (4) Headings are inserted for convenience and shall not affect the construction or interpretation of this Order.
- 3. The Oxfordshire County Council (Various Roads West Oxfordshire) (Prohibition and Restriction of Waiting and Permitted Parking) Order 2012, as amended by the Oxfordshire County Council (Various Roads West Oxfordshire) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.1) Order 2013, and the Oxfordshire County Council (Various Roads West Oxfordshire) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.2) Order 2013 ("the 2012 Order") is amended in the manner and to the extent specified in the Schedule to this Order.

5. Churchill Road:

- (ii) from a point 45 metres north east of the north eastern kerb line of Tilsley Road south westwards to a point 17 metres south west of the south western kerb line of Tilsley Road.

(b) Lay-bys on the north west side:

- (i) from a point 27 metres south west of the south western kerb line of Lords Piece Road south westwards for a distance of 10.5 metres;
- (ii) from a point 48 metres south west of the south western kerb line of Lords Piece Road south westwards for a distance of 10 metres;

- (i) from its junction with West End south westwards for a distance of 42.5 metres;

- (iii) from a point 29.5 metres north east of its junction with Edward Stone Rise south westwards to a point 15 metres south west of the same junction;

- (iv) from a point opposite 10 metres north east of the north eastern kerb line of Lords Piece Road south westwards to a point opposite 16 metres south west of the south western kerb line of Lords Piece Road;
- (v) from a point 21 metres north east of the north eastern kerb line of Hailey Road south westwards to a point 41 metres south west of the south western kerb line of Hailey Road.

6. Church Lane:

- (a) North side from its junction with Spring Street westwards for a distance of 31 metres.
- (b) <u>South side</u> from its junction with Spring Street westwards for a distance of 15 metres.

7. Church Street:

- (a) North side the whole length.
- (b) South side:
 - (i) from its junction with Spring Street westwards for a distance of 39.5 metres;
 - (ii) from a point 92 metres west of its junction with Spring Street westwards for a distance of 15 metres;
 - (iii) from a point 124 metres west of its junction with Spring Street westwards for a distance of 7 metres.

8. Cross Leys:

- (a) <u>Both sides</u> from its junction with The Leys north eastwards for a distance of 11 metres.
- (b) <u>East side</u> from a point 13.5 metres south west of its junction with Leys Approach north eastwards to a point 13 metres north east of that junction.

9. Dunstan Avenue:

- (a) East side:
 - (i) from its junction with New Street southwards for a distance of 48 metres;
 - (ii) from a point 70 metres south of its junction with New Street southwards to a point 40.5 metres south of its junction with Withers Way.

(b) West side:

(i) from its junction with New Street southwards to a point 73 metres north of its junction with Withers Way;

(ii) from a point 42 metres north of its junction with Withers Way southwards for a distance of 82.5 metres.

- (v) from its junction with Horse Fair southwards for a distance of 72 metres.

(b) West side:

- (i) from a point 3 metres north of the southern flank wall of the Town Hall northwards for a distance of 21.5 metres;
- (ii) from a point 43 metres north of the southern flank wall of the Town Hall northwards for a distance of 10 metres;
- (iii) from a point 60 metres north of the southern flank wall of the Town Hall northwards for a distance of 10 metres;
- (iv) from a point 76 metres north of the southern flank wall of the Town Hall northwards for a distance of 16.5 metres;
- (v) from a point 99 metres north of the southern flank wall of the Town Hall northwards for a distance of 56.5 metres.
- (c) West side (A44) from its junction with Horse Fair southwards to its junction with Market Place (A44).

17. Horse Fair:

- (i) from its junction with High Street northwards for a distance of 27.5 metres;
- (ii) from its junction with London Road southwards for a distance of 46 metres.
- (b) West side from its junction with High Street northwards to its junction with Over Norton Road.

18. Leys Approach:

- (a) North east side the whole length.
- (b) South west side:
 - (i) from its junction with Cross Leys south eastwards for a distance of 8.5 metres;

- (ii) from a point 47.5 metres north west of its junction with West End north westwards for a distance of 10 metres:
- (iii) from a point 34.5 metres north west of its junction with West End north westwards for a distance of 6.5 metres;
- (iv) from its junction with West End north westwards for a distance of 14 metres.

19. London Road:

(a) North side

- (i) from its junction with Banbury Road eastwards to a point 42.5 metres east of its junction with Summerton Place.
- (ii) from a point 26.5 metres west of the western kerb line of Rockhill Farm Court eastwards to a point 45 metres east of the eastern kerb line of Rockhill Farm Court
- (b) <u>South side</u> from its junction with Banbury Road eastwards to a point 41.5 metres west of its junction with Summerton Place.

20. Lords Piece Road:

<u>Both sides</u> - from the north western kerb line of Churchill Road north westwards for a distance of 7 metres.

21. Market Place:

- (a) Main route (A361/A44) both sides from its junction with West Street north eastwards to its junction with High Street.
- (b) Minor arm west of Town Hall on the west side of Market Place car park:
 - (i) <u>East side</u> from its southern termination northwards for a distance of 64.5 metres, including the turning area.
 - (ii) <u>West side</u> from its southern termination northwards to a point 4 metres south of its junction with Market Street.
- (c) Northern arm on north side of Market Place Car Park the whole length including the section at its junction with the Minor Carriageway west of Town Hall on the west side of Market Place car park.
- (d) Southern arm (on south side of Town Hall):
 - (i) North side from its junction with the main carriageway of Market Place eastwards for a distance of 7 metres;
 - (ii) South side the whole length.

22. Market Street:

- (a) East side from its junction with Goddards Lane southwards for a distance of 56 metres.
- (b) <u>West side</u> from its junction with Church Street southwards for a distance of 33.5 metres.

23. Middle Row:

- (a) Carriageway on south and east side of Guildhall both sides the whole length.
- (b) The Pedestrianised area north of its junction with Market Place the whole length.

24. New Street:

(a) North side - from its junction with Market Place westwards to a point 97 metres west of its junction with Dunstan Avenue.

(b) South side:

- (i) from its junction with Market Place westwards for a distance of 27.5 metres:
- (ii) from a point 74.5 metres west of its junction with Market Place westwards for a distance of 61.5 metres;
- (iii) from a point 36 metres west of its junction with Dunstan Avenue eastwards for a distance of 97 metres.

25. Over Norton Road:

(a) East side - from its junction with Banbury Road northwards to a point 54 metres north of its junction with Spring Street

(b) West side:

- (i) from its junction with Horse Fair northwards for a distance of 20 metres excluding the lay-by;
- (ii) from a point 34 metres south of its junction with Spring Street northwards to a point 54 metres north of that junction.
- (iii) from a point 27 metres south of the southern kerb line of Wilcox Road northwards to a point 27 metres north of the northern kerb line of Wilcox Road.

26. Rock Hill:

- (a) <u>Both sides</u> from its junction with Albion Street eastwards for a distance of 33.5 metres.
- (b) <u>Lay-by/turning area (adjoining No. 46)</u> from a point 3.5 metres east of the eastern flank wall of No. 46 Rock Hill eastwards for a distance of 16 metres.

27. Rockhill Farm Court (Cul-de-Sac):

All sides - throughout their entire length

28. Rowell Way:

- (a) North side from its junction with Albion Street eastwards to its junction with Shepard Way.
- (b) <u>South side</u> from its junction with Albion Street eastwards to a point 8 metres east of its junction with Shepard Way.

29. Spring Street:

(a) East and south side:

- from its junction with Goddards Lane northwards for a distance of 44.5 metres;
- (ii) from a point 12 metres north east of its junction with Church Lane northwards for a distance of 14.5 metres;

- (i) from its junction with Church Street northwards for a distance of 41 metres;
