OXFORDSHIRE COUNTY COUNCIL (VARIOUS ROADS - WEST OXFORDSHIRE) (PROHIBITION AND RESTRICTION OF WAITING AND PERMITTED PARKING) (VARIATION NO.12) ORDER 2018

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 32 & 45 and Part IV Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

- This Order may be cited as the Oxfordshire County Council (Various Roads – West Oxfordshire) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.12) Order 2018 and shall come into force on the fifth day of February 2018.
- 2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.

- (iv) from its junction with West End north westwards for a distance of 14 metres.

20. London Road:

(a) North side

- (i) from its junction with Banbury Road eastwards to a point 42.5 metres east of its junction with Summerton Place.
- (ii) from a point 26.5 metres west of the western kerb line of Rockhill Farm Court eastwards to a point 45 metres east of the eastern kerb line of Rockhill Farm Court
- (b) <u>South side</u> from its junction with Banbury Road eastwards to a point 41.5 metres west of its junction with Summerton Place.

21. Lords Piece Road:

<u>Both sides</u> - from the north western kerb line of Churchill Road north westwards for a distance of 7 metres.

- (ii) from its junction with Brook Hill south eastwards to a point 0.5 metres south of the southern flank wall of No. 27a Union Street.
- (b) West side the whole length.

25. Upper Brook Hill:

Both sides - the whole length.

26. Vanbrugh Close:

Both sides - from its junction with Rosamund Drive eastwards for a distance of 5 metres.

27. Vermont Drive:

Both sides - the whole length.
