# OXFORDSHIRE COUNTY COUNCIL (VARIOUS ROADS - WEST OXFORDSHIRE) (PROHIBITION AND RESTRICTION OF WAITING AND PERMITTED PARKING) (VARIATION NO.18) ORDER 2019

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35, 45 and 46 of and Part IV Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, make the following Order.

- This Order may be cited as the Oxfordshire County Council (Various Roads West Oxfordshire) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.18) Order 2019 and shall come into force on the 18<sup>th</sup> day of January 2020.
- 2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.
  - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
  - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.
  - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in the 2009 Order.

In the front index – Part VI title and article 22 are deleted and replaced as follows:

In the Index of Schedules - Schedule 44 is deleted and replaced as follows:

#### **"UNLIMITED WAITING**

SCHEDULE 44 Parking Places - No time limit"

In Definitions, the below item is deleted and replaced as follows:

"Timed Parking Place" means any length of road specified in Schedules 32 - 43 which is authorised to be used as a parking place subject to time limits but without payment of any Parking Charge;

4.)

In the articles, Part VI shall be renamed as follows:

## "PART VI PARKING PLACES - NO CHARGE"

Article 22 is deleted and the following are inserted before article 23:

## "Designation of Parking Places - No Time Limit

22. A The length(s) of road specified in Schedule 44 to this Order are authorised to be used, subject to the provisions of Parts V and VI of this Order, as a General Parking Place for vehicles.

## Restrictions on Waiting – Position of Vehicle

- 22. B. No person is to cause or permit a vehicle to wait in a General Parking Place except upon the direction or with the permission of a Civil Enforcement Officer, the Council or a police constable in uniform unless:
- (1) it is parked with every part of the vehicle on the Verge i.e. the paved area as identified in Schedule 44, so that it is entirely within the limits of the Parking Place as marked, save where an exemption as specified in Article 18 applies; and
- (2) where Parking Spaces are marked within a Parking Place it is parked with every part of the vehicle entirely within the limits of a Parking Space as marked, save where an exemption as specified in Article 18 applies; and
- (3) it is parked in position in a single line with the whole nearside or off side of the vehicle adjacent to the highway boundary."

In Schedule 15, Item 5: Bampton is deleted and replaced as follows:

## SCHEDULE 15

## No Waiting at Any Time

"ITEM 5: BAMPTON

- 1. Bridge Street:
- (a) <u>Northwest side</u> from its junction with Cheapside south-westwards for a distance of 22 metres.
- (b) <u>South east side</u> from its junction with High Street south-westwards for a distance of 18 metres.
- 2. Broad Street:

<u>East side</u> - from its junction with Church Street northwards for a distance of 25 metres.

### 3. Cheapside:

<u>Both sides</u> - from its roundabout junction with High Street northwards to its junction with Church Street.

#### 4. Church Street:

South side - from its junction with Cheapside westwards for a distance of 6 20 metres.

### 5. High Street (B4449):

#### (a) North side -

From a point 8 meters east of the extended southeast corner line of the Town Hall, westwards to its roundabout junction with Bridge Street.

### (b) South side -

from its roundabout junction with Bridge Street north-eastwards for a distance of 38.5 metres.

## 6. Market Square:

- (a) East side from its junction with High Street northwards to its junction with Cheapside.
- (b) West side from its junction with Bridge Street north-westwards for a distance of 18.5 metres.
- 7. Rosemary Lane South side from its junction with Bridge Street westwards for a distance of 15m."

  A New Schedule 44 is inserted as follows:

Parking Places - No time limit

ITEMS 1 - 4 Not Used

ITEM 5: BAMPTON

<u>Cheapside</u> – northeast side, from the eastern property boundary of "Old George" eastwards for a distance of 5.5metres, wholly upon the footway.

ITEMS 6 - 81 Not Used".
