#### OXFORDSHIRE COUNTY COUNCIL (VARIOUS ROADS – WEST OXFORDSHIRE) (PROHIBITION AND RESTRICTION OF WAITING AND PERMITTED PARKING) (VARIATION No.29) ORDER 2023

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1, 2, 4, and 32 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order:

- This Order may be cited as the Oxfordshire County Council (Various Roads -West Oxfordshire) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.29) Order 2023 and shall come into force on the 14<sup>th</sup> day of August 2023.
- 2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
  - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
  - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment

The below entry is replaced as follows in Schedule 13 'No Waiting at Any Time':

#### "ITEM 40: HANBOROUGH

1. Lodge Road:

Both sides - from its junction with Main Road southwards and eastwards to a point 17 metres east of the western flank wall of No 1 Lodge Road

2. Main Road (A4095, main carriageway)

Both sides - from a point 77 metres east of the western kerb line of Lodge Road westwards to a point 45 metres east of the 'Pump House'

3. Main Road (service road o/s Nos 212-220)

North side - the whole length

South side – from its junction with the main carriageway eastwards to a point 5 metres west of the eastern property boundary of No 220 Main Road
