

**OXFORDSHIRE COUNTY COUNCIL
(WOODSTOCK, LONG HANBOROUGH & CHARLBURY, VARIOUS ROADS)
(MAP BASED) (PROHIBITION AND RESTRICTION OF WAITING AND
PERMITTED PARKING) (VARIATION No.3) ORDER 2025**

Oxfordshire County Council in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Woodstock, Long Hanborough & Charlbury, Various Roads) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.3) Order 2025 and shall come into force on the 17th day of March 2025.
2. (1) Any reference in this Order to the Council includes any person (including any body corporate) authorised to act on behalf of the Council.

(2) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.

(3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.
3. The Oxfordshire County Council (Woodstock, Various Roads) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) Order 2023, as amended by the Oxfordshire County Council (Woodstock & Long Hanborough, Various Roads) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.1) Order 2024, and the Oxfordshire County Council (Woodstock & Long Hanborough & Charlbury, Various Roads) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.2) Order 2025 ("the 2023 Order") is amended in the manner and to the extent specified in article 2 of this order and in the Schedule to this order.

Amendments to "the 2023 Order"

In article 2 Definitions - the following entry replaces that currently shown:

"Parking Ticket

25. Other than where the Payment Parking Place has a Parking Charge specified in column 2 of Schedule 7 as Nil (free), either

(a) the Parking Charge shall be paid and a Parking Ticket obtained by the insertion into a Ticket Machine at or near the Payment Parking Place (or, if such machine is for the time being defective, at another machine at or near the Payment Parking Place) a coin or coins, of appropriate denomination, to the amount of the Parking Charge or by such other payment method as specified on a Ticket Machine; or

(b) a Virtual Parking Ticket shall be obtained."

provided that if for the time being a notice is displayed at the Parking Place so requiring, the Parking Charge shall be paid to, and a Parking Ticket obtained from, a Parking Attendant."

2.)
