THE CITY OF OXFORD (VARIOUS STREETS COWLEY AREA)
(TRAFFIC REGULATION) CONSOLIDATION (VARIATION) (NO. 2) ORDER 2000

The Oxford City Council ("the Council") as agent for the Oxfordshire County Council in exercise of the powers of the said County Council under Sections 1(1), 2(1) and (2), 32(1), 35(1) and 124(1)(d) of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers makes the following Order:-

- This Order shall come into operation on 20th March 2000 and may be cited as "The City of Oxford (Various Streets Cowley Area) (Traffic Regulation) Consolidation (Variation) (No. 2) Order 2000".
- The City of Oxford (Various Streets Cowley Area) (Traffic Regulation)
 Consolidation Order 1997 ("the principal Order") is hereby varied as follows:-
 - (1) The following allocations to the numbered Articles, Parts and Schedules of the Order are made:-
 - (a) Articles 21 to 24 are renumbered as Articles 22 to 25.
 - (b) Articles 25 and 26 are renumbered as Articles 28 and 29 respectively.
 - (c) Parts IX and X are renumbered as Parts XI and XII respectively.
 - (d) Schedule 9 is renumbered as Schedule 11 and the reference to Schedule 9 in Article 24 is construed as a reference to Schedule 11.
 - (2) Article 20 is deleted and the following is inserted in its place:-
 - "20. (1) No person shall cause any vehicle proceeding in a road specified in column 1 of Schedule 4 to this Order to enter the road specified in relation to that road in column 2 of Schedule 4.
 - (2) In relation to item 3 of Schedule 4, nothing in part (1) of this Article shall apply to any:-
 - (a) pedal cycle;
 - (b) vehicle of the fire, police or ambulance services attending an emergency call."

- (3) The following is added to Schedule 4:-
 - "3. Garsington Road

St. Luke's Road"

- (4) The following is added after Article 20:-
 - "21. (1) No person shall cause any vehicle proceeding in a road specified in Column 1 of Part B of Schedule 4 to this Order to enter the road specified in relation to that road in Column 2 of Part B of Schedule 4.
 - (2) Nothing in part (1) of this Article shall apply to any:-
 - (a) pedal cycle;
 - (b) vehicle of the fire, police or ambulance services attending an emergency call".
- (5) The items in Schedule 4 are described as Part A and a Part B to Schedule 4 is inserted as follows:-

"PART B

Column 1

 Bailey Road, south-east of a point 12 metres south-east of the south-east kerbline of Phipps Road.

Column 2

Bailey Road, north-west of a point 12 metres south-east of the south-east kerbline of Phipps Road.

 Bailey Road, north-west of a point 12 metres south-east of the south-east kerbline.of Phipps Road. Bailey Road, south-east of a point 12 metres south-east of the south-east kerbline of Phipps Road."

(6) The following is added after Part VIII:-

"<u>PART IX</u> NO RIGHT TURNS

25. (1) No person shall cause any vehicle proceeding in a road specified in Column 1 of Schedule 9 to this Order to make a right hand turn into the road specified in relation to that road in Column 2 of Schedule 9.

- (2) Nothing in part (2) of this Article shall apply to any:-
 - (a) pedal cycle;
 - (b) vehicle of the fire, police or ambulance services attending an emergency call"
- (7) The following is added after Schedule 8:-

(8) The following is added after Part IX:-

"PART X

CYCLE LANE

- 26. Save as provided in Article 27 no person shall cause or permit any vehicle not being a bicycle or a pedal cycle to proceed at any time in the lengths of road specified in Schedule 10 to this Order.
- .27. Nothing in Article 26 shall apply:-
 - (a) to any vehicle stopping to enable a person to board or alight;
 - so as to prevent goods being loaded or unloaded onto or from a vehicle at premises in or adjacent to the lengths of road specified in Schedule 10;
 - (c) to any vehicle being used in connection with any building operation, demolition or excavation in or adjacent to the lengths of road specified in Schedule 10, the removal of any obstruction to traffic in those lengths of road, the maintenance, improvement or reconstruction of the lengths of road, or the laying, erection, alteration, removal, repair or servicing in or adjacent to the lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus;

- (d) if a vehicle is being used for the removal of furniture or effects to or from one shop, office or dwellinghouse in or adjacent to the lengths of road described in Schedule 10;
- (e) if the vehicle is in the service of the police or is an ambulance;
- (f) to a vehicle waiting when the person in control of the vehicle is required by law to stop or is obliged to stop in order to avoid an accident or is preventing from proceeding by circumstances outside his control:
- (g) to a vehicle waiting while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged is being opened or closed;
- (h) to a vehicle of the fire service in cases of emergency;
- (i) to a vehicle being used in the service of a local authority, water undertaking or statutory undertaker in pursuance of statutory powers or duties:
- (j) to any vehicle in the service of the Post Office which is waiting while postal packets are being loaded, unloaded, delivered to or collected from premises or posting boxes in or adjacent to a length of road specified in Schedule 10;
- (k) to any bus being used in the provision of a local service waiting at any bus stop in order to set down or pick up passengers."
- (9) The following is added as Schedule 10:-

"SCHEDULE 10

CYCLE LANES

BARNS ROAD

- (a) South-west side:-
 - (i) From the south-east kerbline of Hockmore Street to 151 Barns Road, a distance of 60 metres, occupying an area of carriageway of an average width of 1 metre at an average distance of 1.8 metres from the south-west kerbline.

- (ii) From 151 Barns Road to 131 Barns Road, a distance of 60 metres, for an average width of 1.1 metre from the south-west kerbline.
- (iii) From 131 Barns Road to the north-west kerbline of Dodgson Road, a distance of 80 metres, occupying an area of carriageway of an average width of 1 metre at an average distance of 1.8 metres from the south-west kerbline.
- (iv) From the north kerbline of Lockheart Crescent to the south-east kerbline of Bartholomew Road, a distance of 125 metres, occupying an area of carriageway of an average width of 1 metre at an average distance of 1.8 metres from the south-west kerbline.
- (b) West side; from 5 Barns Road to 17 Barns Road, a distance of 50 metres, occupying an area of carriageway of an average width of 1 metre at an average distance of 1.8 metres from the west kerbline.
- (c) North-east side; from 134 Barns Road to 114 Barns Road, a distance of 90 metres, occupying an area of carriageway of an average width of 1 metre at an average distance of 1.8 metres from the north-east kerbline.
- (d) East side; from 40 Barns Road to 26 Barns Road, a distance of 65 metres, occupying an area of carriageway of an average width of 1 metre at an average distance of 1.8 metres from the east kerbline."

- This Order shall come into operation on 3rd January 1999 and may be cited as "The City of Oxford (Various Streets Cowley Area) (Traffic Regulation)
 Consolidation (Variation) Order 1998".
- The City of Oxford (Various Streets Cowley Area) (Traffic Regulation)
 Consolidation Order 1997 ("the principal Order") is hereby varied as follows:-
 - (1) The expression "prescribed hours" in Article 2 of the principal Order is deleted and the following inserted in its place:
 "prescribed hours" means in relation to any road or length of road specified in Parts A, B, C and D of Schedule 3 the period between 8.00 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive, any such day not being a Christmas Day, Good Friday or a Bank Holiday being a public holiday:"
 - (2) The following is added to the meaning ascribed to the expression "restricted hours" in Article 2 of the principal Order after part (i):-
 - "(ia) in relation to any restricted road specified in Part AA of Schedule 2 to this Order, the period between 8.00 a.m. and 6.00 p.m. on every day of the week;"
 - (3) In sub-paragraph (c) of Article 10 of the principal Order the reference in part (i) to three hours shall be construed as reference to one hour;
 - (4) In sub-paragraph (d) of Article 10 of the principal Order the reference in part (i) to four hours shall be construed as a reference to three hours;
 - (5) The following items are deleted from the specified Schedules to the principal Order:-
 - (a) Part C of Schedule 2 items 15 and 19
 - (b) Part F of Schedule 2 items 14 and 16
 - (c) Part G of Schedule 2 items 6, 15 and 17
 - (d) Part E of Schedule 3 the whole part

- (6) The words "Eastern Bypass Service Road" are deleted in item 24 of Schedule 1 to the principal Order and the words "Eastern Bypass Service and Slip Road" inserted in their place.
- (7) Item 18 in Part A of Schedule 2 to the principal Order is deleted and the following inserted in its place:-
 - "18. Crescent Road
- (a) North-eastern side from the north-western kerbline of Hollow Way north-westwards for a distance of 38 metres.
- (b) North-eastern side from a point 53 metres north-west of the north-western kerbline of Hollow Way north-westwards for a distance of 96 metres.
- (c) North-eastern side from a point 187 metres north-west of the north-western kerbline of Hollow Way, north westwards for a distance of 4 metres.
- (d) North-eastern side from a point 200 metres north-west of the north-western kerbline of Hollow Way north-westward to the eastern kerbline of Crescent Close.
- (e) North-eastern side from the western kerbline of Crescent Close north-westwards for a distance of 22 metres.
- (f) North-eastern side from a point 27 metres north-west of the western kerbline of Crescent Close north-westwards for a distance of 11 metres.
- (g) North-eastern side from a point 55 metres north-west of the western kerbline of Crescent Close north-westwards for a distance of 6 metres.
- (h) North-eastern side from a point 72 metres north-west of the western kerbline of Crescent Close, north-westwards for a distance of 35 metres.

- (i) North-eastern side from a point 190 metres north-west of the western kerbline of Crescent Close to the eastern kerbline of Leafield Road.
- (j) Northern side from the western kerbline of Leafield Road westwards for a distance of 12 metres.
- (k) Northern side from a point 23 metres west of the western kerbline of Leafield Road westwards for a distance of 14 metres.
- (I) Northern side from a point 53 metres west of the western kerbline of Leafield Road westwards for a distance of 22 metres.
- (m) Northern side from a point 85 metres west of the western kerbline of Leafield Road south-westwards for a distance of 40 metres.
- (n) North-western side from a point 141 metres north-west of the western kerbline of Leafield Road south-westwards to the north-western kerbline of Marsh Road.
- (o) South-western side from the north-western kerbline of Hollow Way north-westwards for a distance of 12 metres.
- (p) South-western side from a point 31 metres north-west of the north-western kerbline of Hollow Way north-westwards for a distance of 34 metres.
- (q) South-western side from a point 78 metres north-west of the north-western kerbline of Hollow Way north-westwards to the eastern kerbline of the access road to Crescent Hall.
- (r) South-western side from the western kerbline of the access road to Crescent Hall north-westwards to a point 102 metres

- north-west of the north-western kerbline of Hollow Way.
- (s) South-western side from a point 137 metres north-west of the north-western kerbline of Hollow Way north-westwards to the south-eastern kerbline of Junction Road.
- (t) South-western side from the north-western kerbline of Junction Road for a distance of 86 metres.
- (u) South-western side from a point 96 metres north-west of the north-western kerbline of Junction Road to the south-eastern kerbline of Salesian Gardens.
- (v) South-western side from the north-western kerbline of Salesian Gardens north-westwards for a distance of 44 metres.
- (w) South-western side from a point 55 metres north-west of the north-western kerbline of Salesian Gardens north-westwards for a distance of 48 metres.
- (x) South-western side from a point 115 metres north-west of the north-western kerbline of Salesian Gardens north-westwards for a distance of 11 metres.
- (y) South-western side from a point 153 metres north-west of the north-western kerbline of Salesian Gardens north-westwards for a distance of 71 metres.
- (z) South-western side from a point 236 metres north-west of the north-western kerbline of Salesian Gardens (1 metres north-west of the boundary of 46 and 48 Crescent Road) north-westwards for a distance of 21 metres.
- (aa) South-western side from a point 270 metres north-west of the north-western kerbline of

- Salesian Gardens (adjacent to the boundary of 32 and 34 Crescent Road) westwards for a distance of 4 metres.
- (bb) Southern side from a point 277 metres north-west of the north-western kerbline of Salesian Gardens (adjacent to the western boundary of 30 Crescent Road) westwards for a distance of 34 metres.
- (cc) Southern side from a point 326 metres north-west of the north-western kerbline of Salesian Gardens (1 metre east of the boundary of 10 and 12 Crescent Road) westwards for a distance of 7 metres.
- (dd) Southern side from a point 361 metres west of the north-western kerbline of Salesian Gardens to the north-eastern kerbline of Temple Road."
- (8) Item 21 is deleted from Part A of Schedule 2 to the principal Order and the following is inserted in its place:-

"21. Eastern BypassService and SlipRoad

All sides, from its junction with the Eastern Bypass (A4142) at its junction with Horspath Road*southwards for its entire length".

- (9) Item 33 in Part A of Schedule 2 to the principal Order is deleted and the following inserted in its place:-

- (u) South-western side from a point 102 metres north-west of the north-western kerbline of Purland Close (3 metres east of the boundary of 38 and 40 Temple Road) north-westwards for a distance of 24 metres.

- (v) South-western side from a point 135 metres north-west of the western kerbline of Purland Close (3 metres east of the boundary of 30 and 32 Temple Road) to the south-eastern kerbline of Marsh Road
- (w) North-western side from the northern kerbline of Oxford Road, Cowley northeastwards for a distance of 159 metres.
- (x) North-western side from a point 171 metres north-east of the northern kerbline of Oxford Road, Cowley north-eastwards for a distance of 22 metres.
- (y) North-western side from a point 201 metres north-east of the northern kerbline of Oxford Road, Cowley north-eastwards for a distance of 12 metres.
- (z) North-western side from a point 220 metres north-east of the northern kerbline of Oxford Road, Cowley north-eastwards for a distance of 6 metres.
- (aa) North-western side from a point 236 metres north-east of the northern kerbline of Oxford Road, Cowley north-eastwards to the southwestern kerbline of Temple Road.
- (bb) South-eastern side from the northern kerbline of Oxford Road, Cowley northeastwards for a distance of 48 metres.
- (cc) South-eastern side from a point 53 metres north-east of the northern kerbline of Oxford Road, Cowley north-eastwards for a distance of 7 metres.
- (dd) South-eastern side from a point 65 metres north-east of the northern kerbline of Oxford Road, Cowley north-eastwards for a distance of 14 metres.

- (ee) South-eastern side from a point 89 metres north-east of the northern kerbline of Oxford Road, Cowley to the southern kerbline of Kirby Place.
- (ff) South-eastern side from the northern kerbline of Kirby Place north-eastwards to the southern kerbline of Silkdale Close.
- (gg) South-eastern side from the northern kerbline of Silkdale Close north-eastwards for a distance of 11 metres.
- (hh) South-eastern side from a point 58 metres north-east of the northern kerbline of Silkdale Close north-eastwards to the south-western kerbline of Salegate Lane."
