

- This Order shall come into operation on 27th January 2002 and may be cited as "The Oxfordshire County Council (Disabled Persons' Parking Places -Oxford) Order 2002".
- 2. In this Order, except where the context otherwise requires, the following expressions shall have the meanings assigned to them: -

"disabled person's badge" has the same meaning as in the Disabled Persons' (Badges for Motor Vehicles) (England) Regulations 2000;

"disabled person's parking disc" means a disc issued by a local authority in accordance with the provisions of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"disabled persons' parking place" means a length of road authorised to be used as a parking place for disabled persons' vehicles by Article 5 of this Order;

"disabled person's vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"driver" in relation to a vehicle waiting in a disabled persons' parking place, means the person driving the vehicle at the time it was left in the parking place;

"dual purpose vehicle" has the same meaning as in the Sixth Schedule to the Act of 1984;

"invalid carriage" has the same meaning as in Section 136 of the Act of 1984;

"parking attendant" means a person authorised by or on behalf of the Council under Section 63A of the Act of 1984 to supervise and enforce the restrictions imposed by this Order;

"penalty charge" and "reduced penalty charge" means a charge set by the Council under the provisions of Section 74 of the Road Traffic Act 1991 in accordance with guidance given by the Secretary of State for Transport which is to be paid in the manner described in the penalty charge notice within twenty-eight days of the date of the notice or fourteen days of the date of the notice in the case of a reduced penalty charge;

"penalty charge notice" means a notice issued by a parking attendant pursuant to the provisions of Section 66 of the Road Traffic Act 1991;

"postal packets" has the same meaning as in Section 125 of the Postal Services Act 2000;

"public telecommunications operator" has the same meaning as in Section 9 of the Telecommunications Act 1984;

"relevant position" has the meaning given in Regulation 4 of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"road" means a highway and any other road to which the public has access;

"roundsman" means a person employed by a tradesman to visit customers to take orders and to deliver goods;

"statutory undertaker" has the same meaning as in Section 329 of the Highways Act 1980;

"telecommunications apparatus" has the same meaning as in the Telecommunications Act 1984;

"traffic sign" means a sign or marking of any size, colour or type prescribed or authorised under, or having effect as though prescribed or authorised under, Section 64 of the Act of 1984;

"universal service provider" has the same meaning as in Sections 4(3) and (4) of the Postal Services Act 2000.

 (1) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

- (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations.
- 4. Where a provision of this Order conflicts with a provision of any other Order made under powers contained in the Act of 1984 and of all other enabling powers that provision of this Order shall prevail.

<u>PART II</u>

DISABLED PERSONS' PARKING PLACES

- (1) Each of the lengths of road specified in Schedule 1 to this Order is authorised to be used, subject to the following provisions of this Part of this Order, as a parking place for the classes of vehicles specified in Article 6 only.
 - (2) No vehicle other than of the classes specified in Article 6 shall park at any time in the lengths of road specified in Part A of Schedule 1.
 - (3) No vehicle other than of the classes specified in Article 6 shall park between 8.00 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of road specified in Part B of Schedule 1:-
 - (i) for a period longer than three hours;
 - (ii) if a period of less than one hour has elapsed since the termination during the period specified above of the last period of parking (if any) of the vehicle in the same disabled persons' parking place.
 - (4) No vehicle other than of the classes specified in Article 6 shall park between 8.00 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of road specified in Part C of Schedule 1.
- 6. Each parking place specified in Schedule 1 may be used for the leaving of the following classes of vehicle:-
 - (i) a disabled person's vehicle;
 - (ii) an invalid carriage;
 - (iii) a vehicle issued to a disabled person by the Department of Social Security in lieu of an invalid carriage;

(iv) a vehicle left by the driver thereof, being a vehicle which bears in the relevant position a disabled person's badge,

and in position in single line with the whole nearside or offside of the vehicle (subject during hours of darkness to the provisions of the law on vehicle lighting) adjacent to the kerb in those disabled persons' parking places so indicated in Schedule 1;

- (v) a vehicle being used for any purpose referred to in Article 11 of this
 Order provided it is not reasonable for that vehicle to wait other than in
 a disabled persons' parking place.
- 7. The limits of each disabled persons' parking place shall be indicated by the Council on the carriageway by the appropriate traffic signs and any vehicle standing in a disabled persons' parking place shall stand wholly within the limits so marked.
- 8. The driver of a vehicle using a disabled persons' parking place shall stop the engine as soon as the vehicle is in position in the disabled persons' parking place, and shall not start the engine except when about to change the position of the vehicle in or to depart from the disabled persons' parking place.
- 9. (1) Where a parking attendant or a police officer in uniform is of the opinion that any of the provisions contained in this Part of this Order have been contravened or not complied with in respect of a vehicle left in a disabled persons' parking place he may remove or cause to be removed the vehicle from the disabled persons' parking place and, where it is so removed, he shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle, provided that when a vehicle is parked in a disabled persons' parking place in a position contravening the provisions of this Part of this Order a parking attendant or a police officer in uniform may alter or cause to be altered the position of the vehicle in order that its position shall comply with the provisions.
 - (2) A police officer in uniform may, in case of emergency, move, or cause to be moved to any place he thinks fit, any vehicle left in a disabled persons' parking place.

- (3) Any person authorised to remove a vehicle or alter its position by virtue of parts (1) and (2) of this Article may do so by towing or driving the vehicle or in such other manner as he may think necessary and may take such measures in relation to the vehicle as he may think necessary to enable him to remove it or alter its position as the case may be.
- (1) A parking attendant, police officer in uniform or person authorised by the Council may suspend the use of a disabled persons' parking place or any part thereof whenever he considers such suspension reasonably necessary:-
 - (a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (b) for the purpose of any building operation, demolition or excavation in or adjacent to such a parking place or the maintenance, improvement or reconstruction of such a parking place or the laying, erection, alteration, removal, repair or servicing in or adjacent to such a parking place of any sewer or any main, pipe or apparatus of the supply of gas, water or electricity or of any telecommunications apparatus or traffic sign;
 - (c) for the convenience of occupiers of premises adjacent to the disabled persons' parking place on any occasion of the removal of furniture or household effects to or from a shop, office, or dwellinghouse;
 - (d) on any occasion on which it is likely by reason of some special attraction that any road will be thronged or obstructed, or
 - (e) for the convenience of occupiers of premises adjacent to the disabled persons' parking place at times of weddings or funerals, or on other special occasions.
- (2) Any person suspending the use of a disabled persons' parking place or any part thereof in accordance with the provisions of part (1) of this Article shall thereupon place or cause to be placed in or adjacent to that disabled persons' parking place or the part thereof the use of which is suspended a traffic sign indicating that waiting by vehicles is prohibited.

- (3) No person shall cause or permit a vehicle to be left in a disabled persons' parking place or part of a disabled persons' parking place during any period when there is in or adjacent to that disabled persons' parking place or part thereof a traffic sign placed in pursuance of part (2) of this Article.
- 11. No person shall use any vehicle while it is in a disabled persons' parking place in connection with the sale of any article to any person in or near the disabled persons' parking place or in connection with the selling or offering for hire of his skill or services, provided that nothing in this Article shall prevent the sale of goods from a vehicle by a roundsman.
- 12. Nothing in the foregoing provisions of this Part of this Order shall apply to a vehicle waiting in a disabled persons' parking place, other than a parking place the use of which has been suspended:-
 - (a) so as to prevent any person from causing or permitting any vehicle to wait for the purpose of loading or unloading the vehicle at premises situated on or adjacent to such a parking place;
 - (b) so as to prevent any person from causing or permitting a vehicle to wait for so long as may be necessary to enable a person to board or alight from the vehicle;
 - (c) so as to restrict the use of any vehicle in connection with any funeral, or any vehicle reasonably required in connection with any building operation, demolition or excavation in or adjacent to such a parking place, the removal of any obstruction to traffic in such a parking place, the maintenance, improvement or reconstruction of such a parking place or the laying, erection, alteration, removal, repair or servicing in or adjacent to such a parking place of any sewer or of any main, pipe or apparatus of the supply of gas, water or electricity or of any telecommunications apparatus;
 - (d) to an ambulance or a vehicle in the service of the fire brigade, a local authority, water undertaking, statutory undertaker or police force, in each case being used in pursuance of statutory powers or duties;
 - (e) to any vehicle in the service of or employed by a universal service provider while in use for the purpose of loading, unloading, delivering

or collecting postal packets at premises or posting boxes adjacent to the parking place;

- (f) to a vehicle waiting while any gate or other barrier at the entrance to land or premises to which the vehicle requires access or from which it has emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait otherwise than in the parking place while such gate or other barrier is being opened or closed;
- (g) to any vehicle waiting in any case where the person in control of the vehicle is required by law to stop, or is obliged to do so in order to avoid an accident or is prevented from proceeding by circumstances outside his control;
- (h) to any vehicle in the service of or employed by a public telecommunications operator waiting in any such parking place in connection with the servicing of telephone kiosks or telecommunications apparatus adjacent to that parking place;
- (i) if the vehicle is waiting only for so long as is necessary to enable it to be used in connection with the posting or removing of advertising material in the form of posters, or cleaning windows or chimneys in premises adjacent to the parking place on which the vehicle is waiting,

Provided in each case of the cases mentioned above that the person in control of the vehicle shall move it on the instruction of a police officer in uniform, wherever such moving shall be necessary for the purpose of preventing obstruction.

PART III CONTRAVENTIONS OF THE ORDER

- 13. (1) If a vehicle is left at any time in contravention of a provision of thisOrder a penalty charge shall be payable.
 - (2) In the case of a vehicle in respect of which a penalty charge is payable a penalty charge notice showing the information required by Section 66 of the Road Traffic Act 1991 may then be issued by a parking attendant in accordance with the requirements of Section 66 of that Act.

PART IV REVOCATIONS AND VARIATIONS

- 14. (1) The Orders specified in Schedule 2 to this Order are varied to the extent shown in that Schedule.
 - (2) The Order specified in Schedule 3 to this Order is revoked.
