CXFORDSHIRE COUNTY COUNCIL (OXFORD CENTRAL AREA) (DESIGNATION AND REGULATION OF STREET PARKING PLACES) (VARIATION NO. 1) ORDER 2004

The Oxfordshire County Council, in exercise of its powers under Sections 45 to 53, 124(1)(c) and (d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and having regard to Section 122 of the Act, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. The Oxfordshire County Council (Oxford Central Area) (Designation and Regulation of Street Parking Places) Order 2002 is amended to the extent and in the manner specified in the Schedule to this Order.

2. This Order may be cited as "The Oxfordshire County Council (Oxford Central Area) (Designation and Regulation of Street Parking Places) (Variation No. 1) Order 2004" and shall come into operation on 2 June 2004.

SCHEDULE

The Oxfordshire County Council (Oxford Central Area) (Designation and Regulation of Street Parking Places) Order 2002 is amended as follows:-

1. AMENDMENTS TO EXISTING ORDER FOR REASONS OF CLARIFICATION

(a) The reference to "public telecommunications operator" and "statutory undertaker" inserted in alphabetical order in Article 1 "Interpretation":-

"public telecommunications operator" has the same meaning as in Section 9 of the Telecommunications Act 1984;

"statutory undertaker" has the same meaning as in Section 329 of the Highways Act 1980;

- (b) The reference to "public utility" in Article 15, Part (I) is deleted and should read "statutory undertaker or public telecommunications operator".
- (c) The reference to Second Schedule, Part 1(a), "Saturday" should read "Sunday".
- (d) The reference to Parts I and III in Second Schedule, Part 1(c) is deleted.
- (e) Second Schedule, Part I(d) is renumbered as (e).
- (f) Second Schedule, Part I(d) is inserted as follows:-
 - "(d) Period of stay commencing during that part of the charging hours which apply to Parts I and III of the First Schedule falling between 6.30 pm and 10.00 pm on Monday to Sunday.
 - £1.50 Any length of stay"

2. BROAD STREET PAY AND DISPLAY PARKING

(a) The following is added to the First Schedule:-

"PART V (CHARGING HOURS 8.00 AM - 10.00 PM ANY DAY)

1. BROAD STREET

In the centre of the carriageway from a point 6 metres east of the eastern kerbline of Turl Street measured from the northern side, eastwards for a distance of 62 metres at a distance of 8 metres from the northern kerbline and for an average width of 5 metres."

- (b) Reference to Part V to be inserted into the Second Schedule, Part 1(d).
- (c) The following is added to the Second Schedule after part (e):-
 - "(f) Period of stay commencing during that part of the charging hours which apply to Part V of the First Schedule falling between 8.00 a.m. and 6.30 p.m. on Monday to Sunday.
 - £1.50 One Hour"
