

ROAD TRAFFIC REGULATION ACT 1984

OXFORDSHIRE COUNTY COUNCIL (CITY OF OXFORD AND NORTH HINKSEY) (TRAFFIC MANAGEMENT ACT 2004 – CONSEQUENTIAL PROVISIONS) ORDER 2008

The Oxfordshire County Council (“the Council”) in exercise of their powers under Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and all other enabling powers make the following Order.

1. This Order shall come into operation on the 31st March 2008 and may be cited as the Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2004 - Consequential Provisions) Order 2008
2.
 - (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
3. The orders (“the Orders”) specified in the Schedule to this order shall be amended so that:
 - (1) A definition of any of the following terms set out in any Order is revoked:

parking attendant
Parking Attendant
penalty charge
Penalty Charge
penalty charge notice
Penalty Charge Notice
 - (2) There is incorporated in each of the Orders the following definitions:

“Civil Enforcement Officer” means a person authorised under Section 76 of the Traffic Management Act 2004 to undertake enforcement of parking contraventions (as defined in that Act) and a parking attendant authorised under Section 63A of the Road Traffic Regulation Act 1984 to supervise and enforce these restrictions imposed by any of the provisions of order is a Civil Enforcement Officer.

“Penalty Charge “means a penalty charge imposed further to Part 6 of the Traffic Management Act 2004 and set by Oxfordshire County Council further to paragraph 3 of Schedule 9 to that Act.

“Penalty Charge Notice” means a notice issued by a Civil Enforcement Officer pursuant to regulations made further to Part 6 of the Traffic Management Act 2004.

- (3) Any reference in any Order to a "parking attendant" or "Parking Attendant" shall take effect as if it was a reference to a Civil Enforcement Officer.
 - (4) Any provision in any Order to the following effect is revoked:
 - (a) any provision that if a vehicle is left in contravention of the Order (or certain provisions of the Order) a penalty charge will be payable.
 - (b) any provision to the effect that in the case of a vehicle in respect of which a penalty charge is payable a penalty charge notice may then be issued by a parking attendant.
 - (c) Any provision specifying the amount of the penalty charge
 - (5) There is incorporated at the end of the Articles of each Order the following:
 - " (1) If a parking contravention (as defined in the Traffic Management Act 2004) is committed in contravention of any of the provisions of this order a Penalty Charge will be payable.
 - (2) In the case of a vehicle in respect of which a Penalty Charge is payable a Penalty Charge Notice may be issued by a Civil Enforcement Officer".
4. In the event of any conflict between the provisions of this order and the provisions of the Orders specified in the Schedule to this Order, the former shall prevail.

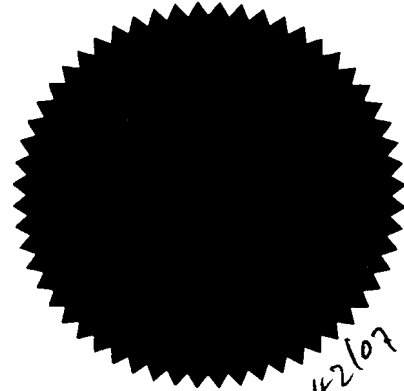
