

ROAD TRAFFIC REGULATION ACT 1984

OXFORDSHIRE COUNTY COUNCIL (HEADINGTON NORTH EAST) (CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS) (VARIATION NO.3) ORDER 2008

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1 (1), 2 (1) and 2 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, makes the following Order:

1. This Order shall come into operation on the 30th June 2008 and may be cited as the Oxfordshire County (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.3) Order 2008.

2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment

(2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa

(3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment

3. The Oxfordshire County (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) Order 2006 ("the 2006 Order"), as amended by the Oxfordshire County (Headington Quarry, Girdlestone Road, Headington and Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) Order 2007, and the Oxfordshire County (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.2) Order 2008, is amended in the manner and to the extent specified in the Schedule to this Order.

SCHEDULE

Amendments to "the 2006 Order":

1.

In Part B of Schedule 3, delete Paragraphs 7(a) and (b) (London Road Service Road) and insert new Paragraph 7 as follows:

- 7 London Road North side: from a point 1 metre east of the common
Service Road boundary of numbers 313 and 315 London Road,
eastwards for a distance of 8 metres.

2.

In Part B of Schedule 4, delete Paragraph 8(b) (Gurden Place) and insert:
new paragraph 8(b) as follows:

- 8 Gurden Place b) East side: From a point 2 metres south of the north
eastern corner of the turning head, southwards for a
distance of 9 metres.
