ROAD TRAFFIC REGULATION ACT 1984

OXFORDSHIRE COUNTY COUNCIL (VARIOUS STREETS EAST OXFORD) (TRAFFIC REGULATION) (VARIATION No.1) ORDER 2007

The Oxfordshire County Council ("the Council") in exercise of their powers under Sections 1(1), 2(1) and (2), 32(1), 35(1), 45(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, make the following Order:

- 1. This Order shall come into operation on the 30th April 2007 and may be cited as the Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) (Variation No.1) Order 2007.
- 2. In this Order, except where the context otherwise requires, the following expressions have the following meanings:
- 3. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
 - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.
- 4. The Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) Order 2002 (the "2002 Order"), as amended by Schedule 2 to the Oxfordshire County Council (Cowley Road, Oxford) (Traffic Regulation) Order 2005, is amended in the manner and to the extent specified in the Schedule to this Order.
