

ROAD TRAFFIC REGULATION ACT 1984

OXFORDSHIRE COUNTY COUNCIL (CITY OF OXFORD) (JERICHO) (PARKING PLACES AND CONTROLLED PARKING ZONE) (VARIATION NO.5) ORDER 2008

The Oxfordshire County Council, in exercise of their powers under sections 32, 35, 45 and 46 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

1. This Order may be cited as the Oxfordshire County Council (City of Oxford) (Jericho) (Parking Places and Controlled Parking Zone) (Variation No.5) Order 2008 and shall come into force on the 18th day of February 2008.

2.
 - (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment

 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa

 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment

 - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.

3. The City of Oxford (Jericho) (Parking Places and Controlled Parking Zone) Order 2000 ("the 2000 Order") as amended by the City of Oxford (Jericho) (Parking Places and Controlled Parking Zone) (Variation No.1) Order 2001, the Oxfordshire County Council (The City of Oxford) (Jericho) (Parking Places and Controlled Parking Zone) (Variation No.2) Order 2005, the Oxfordshire County Council (The City of Oxford) (Jericho) (Parking Places and Controlled Parking Zone) (Variation No.3) Order 2005, and the Oxfordshire County Council (The City of Oxford) (Jericho) (Parking Places and Controlled Parking Zone) (Variation No.4) Order 2007, is amended in the manner and to the extent specified in the Schedule to this Order.

SCHEDULE

1.

Article 20A (2) of "the 2000 Order" is amended by adding at the end, the following:

"Provided that the Council shall issue no more than one Residents' Parking Permit for each of the Dwellings specified in Schedule 4 Part, AA to remain valid at any one time."

2.

Article 21 (4) is revoked.

3.

Part A of Schedule 4 is revoked and replaced by the following

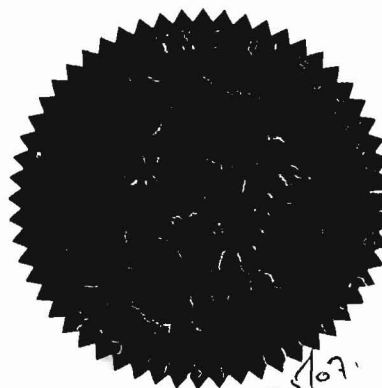
