

**ROAD TRAFFIC REGULATION ACT 1984**

**OXFORDSHIRE COUNTY COUNCIL  
(HEADINGTON NORTH EAST) (CONTROLLED PARKING ZONE  
AND WAITING RESTRICTIONS) (VARIATION NO.2) ORDER 2008**

The Oxfordshire County Council, in exercise of their powers under sections 32, 35, 45 and 46 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Headington North East) (Controlled Parking Zone and Waiting Restrictions) (Variation No.2) Order 2008 and shall come into force on the 18<sup>th</sup> day of February 2008.
2.
  - (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
  - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
  - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
  - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.
3. The Oxfordshire County Council (Headington North East) (Controlled Parking Zone and Waiting Restrictions) Order 2006, as amended by the Oxfordshire County Council (Headington Quarry, Girdlestone Road, Headington and Headington North East) (Controlled Parking Zone and Waiting Restrictions) (Variation) Order 2007, is amended in the manner and to the extent specified in the Schedule to this Order.
