

ROAD TRAFFIC REGULATION ACT 1984

OXFORDSHIRE COUNTY COUNCIL (VARIOUS STREETS COWLEY) (TRAFFIC REGULATION) CONSOLIDATION (VARIATION NO.6) ORDER 2007

The Oxfordshire County Council ("the Council") in exercise of their powers under Sections 1(1), 2(1), 32(1), 35(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, make the following Order:

1. This Order shall come into operation on the 17th December 2007 and may be cited as the Oxfordshire County Council (Various Streets Cowley) (Traffic Regulation) Consolidation (Variation No.6) Order 2007.
2. In this Order, except where the context otherwise requires, the following expressions have the following meanings:
 - (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
 - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.
3. The City of Oxford (Various Streets Cowley Area) (Traffic Regulation) Consolidation Order 1997, as amended by the City of Oxford (Various Streets Cowley Area) (Traffic Regulation) Consolidation (Variation) Order 1998; the City of Oxford (Various Streets Cowley Area) (Traffic Regulation) Consolidation (Variation No.2) Order 2000; the Oxfordshire County Council (Various Streets Cowley Area) (Traffic Regulation) Consolidation (Variation No.3) Order 2003; the Oxfordshire County Council (City of Oxford Various Streets Cowley Area) (Traffic Regulation) Consolidation (Variation No.4) Order 2007, and the Oxfordshire County Council (Various Streets Cowley Area) (Traffic Regulation) Consolidation (Variation No.5) Order 2007 ("the 1997 Order") is hereby amended in the manner and to the extent shown in the Schedule to this order.

SCHEDULE

Amendments:

The City of Oxford (Various Streets Cowley Area) (Traffic Regulation) Consolidation Order 1997 (as amended) is amended as follows:

1.

In Schedule 2 Part A of the 1997 Order - No Waiting at Any Time, item No 33 Junction Road - sub-paragraph (b) is deleted and a new sub-paragraph is inserted:

"(b) South eastern side from a point 83 metres south-west of the south western kerb line of Crescent Road, south-westwards for a distance of 15 metres."

2.

In Schedule 2 Part C of the 1997 Order - No Waiting between 8.00am and 6.30pm on Monday to Saturday Inclusive, item 12 Hendred Street, shall be deleted and replaced by:

"12 Hendred Street North western side, from a point 15m southwest of the south western kerb line of Oxford Road, south westwards for a distance of 10.5m."

3.

In Schedule 3 Part E of the 1997 Order - Parking Places Without Time Limit, item 2 (b) Junction Road is deleted and replaced by:

"(b) South eastern side from a point 98m southwest of the south western kerb line of Crescent Road, south westwards for a distance of 78m."
