# THE OXFORDSHIRE COUNTY COUNCIL (VARIOUS STREETS COWLEY AREA) (TRAFFIC REGULATION) CONSOLIDATION (VARIATION NO.7) ORDER 2008

The Oxfordshire County Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 1(1), 2, 32(1) & 35(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and having regard to Section 122 of the Act, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

- 1 This Order may be cited as The Oxfordshire County Council (Various Streets Cowley Area) (Traffic Regulation) Consolidation (Variation No.7) Order 2008 and shall come into operation on the 5<sup>th</sup> May 2008.
- 2 The City of Oxford (Various Streets Cowley Area) (Traffic Regulation) (Consolidation) Order 1997 ("the 1997 Order"), as amended by the City of Oxford (Various Streets Cowley Area) (Traffic Regulation) Consolidation (Variation) Order 1998; the City of Oxford (Various Streets Cowley Area) (Traffic Regulation) Consolidation (Variation No.2) Order 2000; the Oxfordshire County Council (Various Streets Cowley Area) (Traffic Regulation) Consolidation (Variation No.3) Order 2003; the Oxfordshire County Council (Various Streets Cowley Area) (Traffic Regulation) Consolidation (Variation No.4) Order 2007; the Oxfordshire County Council (Various Streets Cowley Area) (Traffic Regulation) Consolidation (Variation No.5) Order 2007, and the Oxfordshire County Council (Various Streets Cowley Area) (Traffic Regulation) Consolidation No.6) Order 2007, is amended to the extent and in the manner specified in the Schedule to this Order.

Schedule 2 - Waiting Restrictions - Part A - No Waiting at any time

Item 45 is deleted and the following inserted:

"45. Phipps Road (a) Both sides, from the south-western kerb line of Garsington Road south-westwards for a distance of 18 metres.

(b) Both sides, from the north-eastern kerb line of Bailey Road north-eastwards for a distance of 20 metres."

Item 12 is deleted and the following inserted:

"12. Phipps Road South-eastern side, from a point 18 metres south-west of the south-western kerb line of Garsington Road south-westwards to a point 20 metres north-east of the north-eastern kerb line of Bailey Road."

Schedule 2 - Part G - No Waiting between 3.00pm and 4.00pm on Mondays to Fridays inclusive.

Item 4 is deleted and the following inserted:

"4. Boswell Road

North-eastern and south-eastern sides, from its junction with Bailey Road southeastwards then south-westwards to a point 15 metres north-east of the north-eastern kerb line of Barns Road". 4.

Schedule 2 - Part G - No Waiting between 3.00pm and 4.00pm on Mondays to Fridays inclusive.

Item 13 is deleted and the following inserted:

"13. Phipps Road North-western side, from a point 18 metres south-west of the south-western kerb line of Garsington Road south-westwards to a point 20 metres north-east of the north-eastern kerb line of Bailey Road."

### 5.

Schedule 4 - Prohibition of Entry - Part B (Bailey Road) - is deleted and the following (Phipps Road) inserted:

1. Phipps Road, north-east of a point 5 metres north-east of the north-eastern kerb line of Bailey Road.

2. Phipps Road, south-west of a point 6 metres north-east of the north-eastern kerb line of Bailey Road.

Phipps Road, south-west of a point 6 metres northeast of the north-eastern kerb line of Bailey Road.

Phipps Road, north-east of a point 7 metres northeast of the north-eastern kerb line of Bailey Road."
