

ROAD TRAFFIC REGULATION ACT 1984

OXFORDSHIRE COUNTY COUNCIL (HEADINGTON NORTH EAST) (CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS) (VARIATION NO.5) ORDER 2008

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1 (1), 2 (1), 2 (2) & 32(1)(a), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, makes the following Order:

1. This Order shall come into operation on the 22nd September 2008 and may be cited as the Oxfordshire County (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.5) Order 2008.
2.
 - (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
3. The Oxfordshire County (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) Order 2006 ("The 2006 Order"), as amended by the Oxfordshire County (Headington Quarry, Girdlestone Road, Headington and Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) Order 2007; the Oxfordshire County (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.2) Order 2008; the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.3) Order 2008, and the Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2004 - Consequential Provisions) Order 2008, is amended in the manner and to the extent specified in the Schedule to this Order.

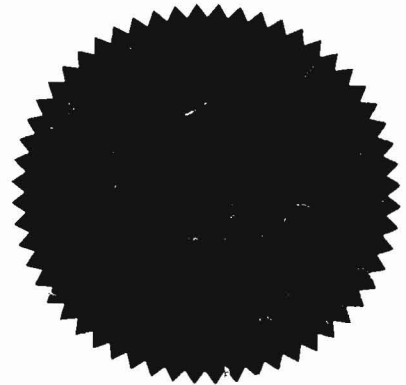
SCHEDULE

The "The 2006 Order" Schedule 4, Part B, Permit Holders Parking Places, 9am to 5pm Monday to Friday, is amended by deleting the existing item 3 and replacing as follows:

- "3 Blackthorn Close
- (a) North side: From a point 9 metres west of the western kerb line of Barton Road, westwards for a distance of 12 metres.
 - (b) North side: From a point 36 metres west of the western kerb line of Barton Road, westwards for a distance of 9 metres."
