

**THE OXFORDSHIRE COUNTY COUNCIL
(VARIOUS STREETS EAST OXFORD)
(TRAFFIC REGULATION) (VARIATION No.4) ORDER 2009**

The Oxfordshire County Council ("the Council") in exercise of their powers under Sections 1(1) and 2(1) of the Road Traffic Regulation Act 1984 ("the Act of 1984") and Part IV of Schedule 9 of the Act and after consultation with the Chief Officer of Police in accordance with Part IV of Schedule 9 and of all other enabling powers make the following Order:

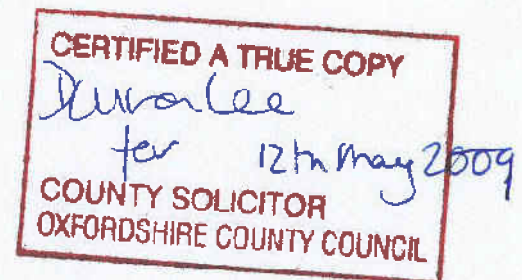
This order shall be cited as the Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) (Variation No.4) Order 2009 and shall come into force on the 18th May 2009.

1. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.

(2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.

(3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.
2. The Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) Order 2002 ("the 2002 Order") as amended by the Oxfordshire County Council (Cowley Road, Oxford) (Traffic Regulation) Order 2005, the Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) (Variation No.1) Order 2007, and the Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2004 - Consequential Provisions) Order 2008, shall be amended in the manner and to the extent specified in the Schedule to this Order.

SCHEDULE

Amendments to 'the 2002 Order'

The following paragraph is added to Schedule 2 - No Waiting at Any Time

"28A	Reliance Way	<p>a) southwest side - from a point 1.5 metres southeast of the front wall of 41 Saunders Road, in a north-westerly direction for 21 metres</p> <p>b) southwest side - from a point 2.7 metres southeast of a point in line with the flank wall of 15 Reliance Way in a north westerly then south-westerly direction for 9.6 metres (as measured at the edge of the main carriageway)</p> <p>c) northwest side - from a point 0.5 metres northeast of the rear wall of 42 Reliance Way in a north-easterly then north-westerly direction for 29.7 metres (as measured at the edge of the main carriageway)</p> <p>d) northeast side - from the south-eastern flank wall of 20 Reliance Way in a south-easterly direction for 5.3 metres"</p>
