 - (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
 - (3) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.

The City of Oxford (Headington West) (Controlled Parking Zone) Order 2000 as amended by the Oxfordshire County Council (Headington West) (Controlled Parking Zone) (Variation No.1) Order 2007, the Oxford Oxfordshire County Council (Headington West) (Controlled Parking Zone) Order (Variation No.2) Order 2008, the Oxford Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2004 Consequential Provisions) Order 2008, the Oxford Oxfordshire County Council (Headington West) (Controlled Parking Zone) Order (Variation No.4) Order 2008 and the Oxford Oxfordshire County Council (Headington West) (Controlled Parking Zone) Order (Variation No.5) Order 2008 ("the 2000 Order") is amended in the manner and to the extent specified in the Schedule to this Order.
- The Oxford Oxfordshire County Council (Headington West) (Controlled Parking Zone) (Variation No.5) Order 2008 is hereby revoked.
