

**THE OXFORDSHIRE COUNTY COUNCIL (MARSTON SOUTH)
(CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS)
(VARIATION No.2) ORDER 2009**

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2), 32(1), 35(1), 37, 45, 46, 49(4) & 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order:

This Order shall come into operation on the 16th November 2009 and may be cited as the Oxfordshire County Council (Marston South) (Controlled Parking Zone and Waiting Restrictions) (Variation No.2) Order 2009.

1. (1) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
- (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
- (3) Any reference in this Order to a numbered Article shall unless the context otherwise requires be construed as a reference to the numbered Article bearing that number in this Order.

2. The Oxfordshire County Council (Marston South) (Controlled Parking Zone and Waiting Restrictions) Order 2007, as amended by the Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2004 – Consequential Provisions) Order 2008 ("the 2007 Order"), is amended in the manner and to the extent specified in the Schedule to this Order.

From Page 6 of the Order, the following definitions are deleted and replaced as follows:

"Business Permit" means a permit issued by the Council to a business under the provisions of Part VIII of this order to park a permitted vehicle, subject to the provisions of this order, in the Permitted Parking Places or without time limit in the Timed Parking Places specified in Parts B, C, D, E & F of Schedule 3;"

"Hotel Visitors' Permit" means a permit issued by the Council to a hotel or guesthouse under the provisions of Part X of this Order to park a Permitted Vehicle, subject to the provisions of this Order, in the Permit Parking Places or without time limit in the Timed Parking Places specified in Parts B, C, D, E & F of Schedule 3;"

"Permit Parking Place" means any length of road specified in Parts B, C or D of Schedule 4 to this Order which is authorised to be used as a parking place, subject to the provisions of this Order, by a Permitted Vehicle which displays in the Relevant Position a valid Residents' Permit, a valid Business Permit, a valid Visitors' Permit or a valid Hotel Visitors' Permit;"

"Prescribed Hours" means:

- (a) in relation to any length of road specified in Parts A & B of Schedule 3 the period between 8.00 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (excluding Christmas Day, Good Friday and bank holidays);
- (b) in relation to any length of road specified in Parts C, D, E & F of Schedule 3, the period between 8.00am and 6.30pm on Mondays to Fridays inclusive (excluding Christmas Day, Good Friday and bank holidays);
- (c) In relation to any length of road specified in Part B of Schedule 4 the period between 9.00am and 5.00pm on Mondays to Saturdays inclusive (excluding Christmas Day, Good Friday and bank holidays)
- (d) In relation to any length of road specified in Part C & D of Schedule 4 the period between 9.00am and 5.00pm on Mondays to Fridays inclusive (excluding Christmas Day, Good Friday and bank holidays)"

"Residents' Permit" means a permit issued by the Council to a Resident under the provisions of Part VI of this Order to park, subject to the provisions of this Order, the vehicle in respect of which the permit has been issued, in the Permit Parking Places or without time limit in the Timed Parking Places specified in Parts B, C, D, E & F of Schedule 3;"

"Restricted Hours" means

- (a) in relation to any Restricted Road specified in Part A of Schedule 2, 24 hours of every day
- (b) in relation to any Restricted Road specified in Part B of Schedule 2, the period between 8.00am and 6.30pm on Mondays to Fridays inclusive
- (c) in relation to any Restricted Road specified in Part B of Schedule 2, the period between 9.30am and 4.00pm on Mondays to Fridays inclusive;"

"School Permit" means a permit issued by the Council to the School under the provisions of Part IX of this Order to park a Permitted Vehicle, subject to the provisions of this Order, in the Permit Parking Places or without time limit in the Timed Parking Places specified in Parts B, C, D, E & F of Schedule 3"

"Temporary Permit" means a permit issued by the Council to a Resident under the provisions of Article 29 of this order to park, subject to the provisions of this Order, the vehicle in respect of which the permit has been issued in the Permit Parking Places or without time limit in the Timed Parking Places specified in Parts B, C, D & F of Schedule 3 to this Order"

"Timed Parking Place" means any length of road specified in Parts B, C, D, E & F of Schedule 3 to this Order which is authorised to be used further to Part III of this Order as a parking place by a Permitted Vehicle, subject to the provisions of this Order;"

"Visitors' Permit" means a permit issued by the Council to a Resident under the provisions of Part VII of this Order to enable a person visiting the Resident to park a Permitted Vehicle, subject to the provisions of this Order, in the Permit Parking Places or without time limit in the Timed Parking Places specified in Parts B, C, D, E & F of Schedules;"

From Page 14 of the Order, Part III General Parking Places - the following articles are deleted and replaced accordingly:

"Authorisation of Timed Parking Places

8. Each of the lengths of road specified in Parts B, C, D, E & F of Schedule 3 to this Order is authorised to be used, subject to the provisions of Part III, IV, and V of this Order, as a parking place for Permitted Vehicles.

Restrictions on Waiting

9. No person is to cause or permit a vehicle to wait in a Timed Parking Place unless:

- (1) it is a Permitted Vehicle; and
- (2) in relation to any Timed Parking Place specified in Parts A, B, C & D of Schedule 3, it is parked in position in a single line with every part of the vehicle on the carriageway and so that the whole near side or off side of the vehicle is adjacent to the kerb unless otherwise stated in Part A or Part B of Schedule 3 to this Order, save that any Motor Cycle is to be parked so that it is perpendicular to the kerb; and
- (3) in respect of any Timed Parking Place specified in Parts E & F of Schedule 3, it is parked in position in a single line with the vehicle partly on the carriageway and partly on the footway and so that the whole near side or off side of the vehicle is parallel to the kerb unless otherwise stated in Part C or D of Schedule 3 to this Order, save that any Motor Cycle is to be parked so that it is perpendicular to the kerb; and

- (4) it is entirely within the limits of the Timed Parking Place as marked for Permitted Vehicles.

Time Restriction on Waiting.

10. Save as provided in Articles 12, 17 and 18 (Exemptions), no person is to cause or permit any vehicle to wait during the Prescribed Hours, except upon the direction or with the permission of a Parking Attendant, the Council or a police constable in uniform:-

- (1) in any Timed Parking Place specified in Part A of Schedule 3 to this Order;
 - (a) for a period longer than one hour, or
 - (b) if a period of less than one hour has elapsed since the termination during the Prescribed Hours of the last period of parking (if any) of the vehicle in the same Parking Place
- (2) in any Timed Parking Place specified in Part B, C, or E of Schedule 3 to this Order:
 - (a) for a period longer than two hours, or
 - (b) if a period of less than two hours has elapsed since the termination during the Prescribed Hours of the last period of parking (if any) of the vehicle in the same Parking Place
- (3) in any Timed Parking Place specified in Part D or F of Schedule 3 to this Order:
 - (a) for a period longer than three hours, or
 - (b) if a period of less than three hours has elapsed since the termination during the Prescribed Hours of the last period of parking (if any) of the vehicle in the same Parking Place"

"Exemptions - Permits

12. Nothing in Article 10 will apply to a vehicle waiting in a Timed Parking Place specified in Part B, C, D, E or F of Schedule 3 if the vehicle displays in the Relevant Position a valid Residents' Parking Permit, a valid Visitors' Permit, a valid Business Permit, a Valid School Permit or a valid Hotel Visitors' Permit."

From Page 18 of the Order, the following articles are deleted and replaced accordingly:

PART V

PERMIT PARKING PLACES

"Permit Parking Places

21. Each of the lengths of road specified in Parts B, C, & D of Schedule 4 to this Order is authorised to be used, subject to the provisions of Parts IV to IX of this Order, as a parking place for any Permitted Vehicle which displays in the Relevant Position on the vehicle a valid Residents' Permit, a valid Visitors' Permit, a valid Business Permit or a valid Hotel Visitors' Permit.

Restrictions on Waiting

22. No person is to, cause or permit any vehicle to wait in any Permit Parking Place during the Prescribed Hours, except upon the direction or with the permission of a Parking Attendant, the Council or a police constable in uniform, unless:-

- (1) it is a Permitted Vehicle; and
- (2) in relation to any Permit Parking Place specified in Part B or C of Schedule 4, it is parked in position in a single line with every part of the vehicle on the carriageway and so that the whole near side or off side of the vehicle is adjacent to the kerb unless otherwise stated in Part B or C of Schedule 4 to this Order, save that any Motor Cycle is to be parked so that it is perpendicular to the kerb; and
- (3) in respect of any Permit Parking Place specified in Part D of Schedule 4, which is parked in position in a single line with the vehicle partly on the carriageway and partly on the footway and so that the whole near side or off side of the vehicle is parallel to the kerb unless otherwise stated in Part D of Schedule 4 to this Order, save that any Motor Cycle is to be parked so that it is perpendicular to the kerb; and
- (4) it is entirely within the limits of the Permit Parking Place as marked; and
- (5) save as provided in Articles 17 and 18 (Exemptions), there is displayed in the Relevant Position on the vehicle at all times during which the vehicle is left in the Permit Parking Place during the Permitted Hours a valid Residents' Parking Permit in respect of that vehicle, a valid Visitors' Permit, a valid Business Permit or a valid Hotel Visitors' Permit provided that this requirement to display a permit does not apply to a Motor Cycle

and where the Council, in the exercise of its discretion further to Article 22 agrees to authorise the use of any Permit Parking Place by a vehicle in connection with works at premises in the area stated in Schedule 1 to this Order, the charge for such authorisation will be £15 index linked for any period not exceeding a week."


