#### **ROAD TRAFFIC REGULATION ACT 1984**

# OXFORDSHIRE COUNTY COUNCIL (VARIOUS STREETS, OXFORD) (WAITING AND LOADING RESTRICTIONS) CONSOLIDATION (VARIATION NO.1) ORDER 2010

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1 (1), 2 (1) & (2) and 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

- This Order shall come into force on the first day of March 2010 and may be cited as Oxfordshire County Council (Various Streets, Oxford) (Waiting And Loading Restrictions) Consolidation (Variation No.1) Order 2010.
- (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
  - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
  - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
  - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.
- 3. The Oxfordshire County Council (Various Streets, Oxford) (Waiting and Loading Restrictions) Consolidation Order 2009 ("the 2009 Order") shall be amended in the manner and to the extent specified in the Schedule to this Order.

Both sides, from its junction with the Eastern Bypass (A4142) to its junction with Watlington Road.

# 34. GODSTOW ROAD

- (a) both sides, from No.145 Godstow Road generally south-westwards for a distance of 799 metres;
- (b) northwest side:
  - (i) from the Wolvercote roundabout to a point 19 metres southwest of the south-western kerb line of Mere Road;

  - (ii) from a point 70 metres southwest of the Wolvercote roundabout to a point 19 metres southwest of the south-western kerb line of Mere Road;
  - (iii) from the south-western kerb line of Wolvercote Green southwestwards for a distance of 14 metres;
  - (iv) from the north-eastern kerb line of Wolvercote Green north-eastwards for a distance of 17 metres.

## 35. HARBORD ROAD

The north and south sides, from the eastern kerb line of Banbury Road eastward for 65 metres.

## 35A HOME CLOSE

- (a) southwest side:
   from a point 6 metres southwest of the common property boundary
   of Nos.1/3 Mere Road, south-eastwards to the northwest kerb line
   of Godstow Road, a distance of 35 metres;
- (b) northeast side,
   (i) from a point 24 metres southwest of the south-western property boundary of No.2 Mere Road, south-westwards to the northwestern kerb line of Godstow Road, a distance of 17.5metres;

#### 52. NEWMAN ROAD

Both sides, from a point 25 metres west of the western kerb line of Cowley Road eastwards to its junction with Long Lane.

# 53. NORTH WAY, BARTON (Northeast of the A40 Northern ByPass)

Both sides, from the north-western kerb line of Godstow Road north-westwards for a distance of 17 metres.

### 58. ROMAN WAY

- (a) the west side, from its junction with Horspath Road, southwards for a distance of 19 metres;
- (b) the east side, from its junction with Horspath Road, southwards for a distance of 15 metres.

#### 58A. ROSAMUND ROAD

- (a) the southwest side, from a point 17 metres southeast of a point opposite the northeast property boundary of No.82 Godstow Road, south-eastwards to the north-western kerb line of Godstow Road, a distance of 10 metres
- (b) the northeast side, from a point 17 metres southeast of the northeast property boundary of No.82 Godstow Road southeastwards to the north-western kerb line of Godstow Road, a distance of 9.5 metres

#### 59. ROSE HILL

Both sides, from its junction with Henley Avenue southward to a point 17 metres north of the northern kerb line of Ashurst Way;

## 60. ROSE HILL SERVICE ROAD

east side:

- (i) from its junction with Rose Hill at the north junction with Courtland Road northward to the junction with Rose Hill and Villiers Lane;
- (ii) from a point 8 metres north of a point opposite the boundary between Nos.82 and 84 Rose Hill northward to its junction with Rose Hill.

## 61. ROTHA FIELD ROAD

Both sides, from the south-eastern kerb line of Five Mile Drive south-eastwards for a distance of 16 metres.

## 62. SANDY LANE

- (a) northwest and west sides:
- (i) from a point 8 metres south of the southern kerb line of Furlong Close to a point 15 metres north of the northern kerb line of Furlong Close;
- (ii) from a point 14 metres south of the southern kerb line of Allin Close to a point 15 metres north of the northern kerb line of Allin Close;
- (iii) from a point 15 metres southwest of the south-western kerb line of Kent Close to a point 15 metres northeast of the north-eastern kerb line of Kent Close;
- (iv) from a point 24 metres southwest of the south-western kerb line of the garage access road adjacent to No.45 Sandy Lane to a point 25 metres northeast of the north-eastern kerb line of the said garage access road;
- (b) southeast and south sides:
- (i) from a point 8 metres southwest of the south-western kerb line of the garage access road between Nos.28 and 30 Sandy Lane to a point 15 metres northeast of the north-eastern kerb line of the said garage access road and extending into the garage access road on both sides for 12 metres from the south-eastern kerb line of Sandy Lane;
- (ii) from a point 15 metres east of the eastern kerb line of Druce Way to a point 15 metres west of the western kerb line of Druce Way;
- (iii) from a point 26 metres east of the eastern kerb line of Tucker Road to a point 21 metres west of the western kerb line of Tucker Road;
- (iv) from a point 51 metres east of the eastern kerb line of Ladenham Road to a point 15 metres west of the western kerb line of Ladenham Road.
- (c) the access ways leading from all the lengths of roads specified in (a) & (b) above.
- (d) the south side:
- (i) from its junction with the A4142 Oxford Eastern Bypass east to a point 12 metres west of its junction with Spring Lane;
- (ii) from the centre line of its junction with Spring Lane eastwards for a distance of 12 metres.
- (iii) from the centre line of its junction with Broadfields westwards for a distance of 15 metres.
- (iv) from its junction with Broadfields eastwards to its junction with Costar Close.
- (v) from the centre line of its junction with Costar Close eastwards for a distance of 10 metres.
- (e) the north side, from its junction with the A4142 Oxford Eastern Bypass to a point 15 metres east of its junction with Bampton Close.

# 63. SEACOURT PARK-AND-RIDE CAR PARK ACCESS ROAD

Both sides, including the bus turning area at the northern end of the access road.

## 64. SPRING LANE

Both sides, from its junction with Sandy Lane West for a distance of 10 metres.

# 65. STOWFORD ROAD

Both sides, from the western kerb line of Bayswater Road westwards for a distance of 15 metres.

## 66. SWINBOURNE ROAD

Both sides, from the eastern kerb line of Oxford Road eastwards for a distance of 15 metres.

## 67. THE ROUNDWAY

Southeast side, from its junction with London Road south-westwards to point 2 metres southwest of the south-western boundary of No.298 London Road, an approximate distance of 35 metres.

### 68. THE SLADE

- (a) east side:
- (i) from the centre line of Cinnaminta Road southward for a distance of 65.85 metres;
- (ii) from the centre line of Cinnaminta Road northward for a distance of 21 metres;
- (b) west side:

from the centre line of Cinnaminta Road southward for a distance of 65.85 metres;

# 69. TITUP HALL DRIVE

East side

- (a) from the extended kerb line of its junction with Masons Road, northwards for 11.6 metres;
- (b) from the extended kerb line of its junction with Masons Road, southwards for 13 metres.

## 70. TRANSPORT WAY

- (a) Southeast side:
- (i) from a point 86 metres north east of the north-eastern kerb line of Watlington Road, north-eastwards for 79 metres;

  - (ii) from the north-western kerb line of Dove House Close northwestwards for a distance of 16 metres;
  - (iii) from the south side of Dove House Close for a distance of 113 metres from Wolvercote Green into First Turn."
