

**ROAD TRAFFIC REGULATION ACT 1984
OXFORDSHIRE COUNTY COUNCIL (WALTON MANOR OXFORD)
(PARKING PLACES AND TRAFFIC MANAGEMENT) (CONSOLIDATION)
(VARIATION No.8) ORDER 2010**

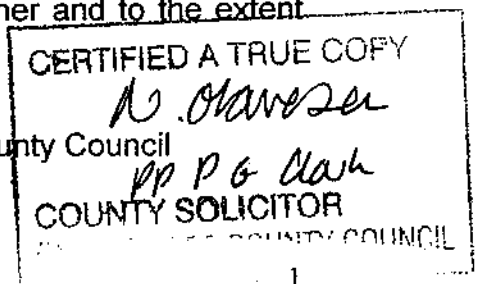
The Oxfordshire County Council ("the Council") in exercise of their powers under Sections 32, 35, 45 and 46 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order:

1. This Order shall come into operation on the 1st March 2010 and may be cited as the Oxfordshire County Council (Walton Manor Oxford) (Parking Places and Traffic Management) (Consolidation) (Variation No.8) Order 2010.
2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment

(2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa

(3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment

The Oxfordshire County Council (Walton Manor, Oxford) (Parking Places and Traffic Management) (Consolidation) Order 2003, as amended by the Oxfordshire County Council (City of Oxford) (Walton Manor) (Parking Places and Traffic Management) (Consolidation) (Variation No.1) Order 2005, the Oxfordshire County Council (City of Oxford) (Walton Manor) (Parking Places and Traffic Management) (Consolidation) (Variation No.2) Order 2006, the Oxfordshire County Council (City of Oxford) (Walton Manor) (Parking Places and Traffic Management) (Consolidation) (Variation No.3) Order 2006 the Oxfordshire County Council (Walton Manor, Oxford) (Parking Places and Traffic Management) (Consolidation) (Variation No.4) Order 2007, the Oxfordshire County Council (Walton Manor, Oxford) (Parking Places and Traffic Management) (Consolidation) (Variation No.5) Order 2008, the Oxfordshire County Council (City of Oxford & North Hinksey) (Traffic Management Act 2004 - Consequential Provisions) Order 2008, and the Oxfordshire County Council (Walton Manor, Oxford) (Parking Places and Traffic Management) (Consolidation) (Variation No.7) Order 2009 ("the 2003 Order") is amended in the manner and to the extent specified in the schedule to this Order.

Amendments to "the 2003 Order":

SCHEDULE 5

PART A

Permit Holders' Parking - 24-Hours of Every Day

Delete Existing Item 9 and replace as follows:

- "9. Tackley Place
- (a) Northern side; from a point 13 metres east of the eastern kerb line of Kingston Road, eastwards for a distance of 19 metres.
 - (b) Northern side; from a point 44 metres east of the eastern kerb line of Kingston Road, eastwards for a distance of 7 metres.
 - (c) Northern side; from a point 58 metres east of the eastern kerb line of Kingston Road, eastwards for a distance of 7 metres.
 - (d) Northern side; from a point 74 metres east of the eastern kerb line of Kingston Road, eastwards for a distance of 8 metres.

- (e) Northern side; from a point 13 metres west of the western kerb line of Warnborough Road, westwards for a distance of 30 metres.
- (f) Southern side; from a point 45 metres east of the eastern kerb line of Kingston Road, eastwards for a distance of 5 metres.
- (g) Southern side; from a point 80 metres east of the eastern kerb line of Kingston Road, eastwards for a distance of 8.5 metres.
- (h) Southern side; from a point 14 metres west of the western kerb line of Warnborough Road, westwards for a distance of 20 metres."
