ROAD TRAFFIC REGULATION ACT 1984

OXFORDSHIRE COUNTY COUNCIL (CITY OF OXFORD) (VARIATION OF CHARGES FOR RESIDENTS' PERMITS) ORDER 2010

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 45 and 46 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, make the following Order:-

- This Order shall come into operation on 1 January 2011 and may be cited as the Oxfordshire County Council (City of Oxford and North Hinksey) (Variation of Charges for Residents' Permits) Order 2010
- 2. In this Order, the expression "Parking Orders" means the orders listed in column 1 of the Schedule to this Order.
- 3. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
- The Parking Orders are hereby varied as follows:-

(1) In each of the Articles of the Parking Orders listed in column 2 of the Schedule to this Order all references to £40 per annum index CERTIFIED A TRUE (Inked are revised to £50 per annum index linked (Inked (I
