

**THE OXFORDSHIRE COUNTY COUNCIL
(HEADINGTON CENTRAL) (CONTROLLED PARKING ZONE AND VARIOUS
RESTRICTIONS) (VARIATION NO.12) ORDER 2011**

The Oxfordshire County Council, in exercise of its powers under Sections 32, 35, 45 & 46 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

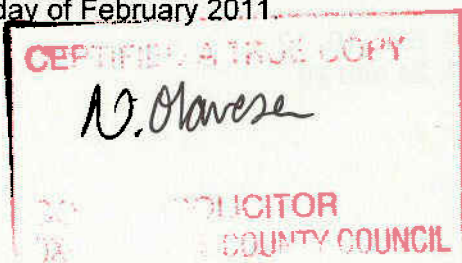
1. This Order may be cited as the Oxfordshire County Council (Headington Central) (Controlled Parking Zone and Various Restrictions) (Variation No.12) Order 2011 and shall come into operation on the 7th day of February 2011.
2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment

(2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa

(3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment

(4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.

The Oxfordshire County Council (Headington Central) (Controlled Parking Zone and Various Restrictions) Order 2005, as amended by the Oxfordshire County Council (Headington Central) (Controlled Parking Zone and Various Restrictions) (Variation No 1) Order 2007, the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) Order 2007, the Oxfordshire County Council (Headington Central) (Controlled Parking Zone and Various Restrictions) (Variation No.2) Order 2008, the Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2004 - Consequential Provisions) Order 2008, the Oxfordshire County Council (Headington Central) (Controlled Parking Zone and Various Restrictions) (Variation No.4) Order 2008, the Oxfordshire County Council (Headington Central) (Controlled Parking Zone and Various Restrictions) (Variation No.5) Order 2008, the Oxfordshire County Council (Headington Central) (Controlled Parking Zone and Various Restrictions) (Variation No.6) Order 2009, the Oxfordshire County Council (Headington Central) (Controlled Parking Zone and Various Restrictions) (Variation No.7) Order 2009, the Oxfordshire County Council (Headington Central) (Controlled Parking Zone and Various Restrictions) (Variation No.8) Order 2009, the Oxfordshire County Council (Headington Central) (Controlled Parking Zone and Various Restrictions) (Variation No.10) Order 2010, and the Oxfordshire County Council (Headington Central) (Controlled Parking Zone and Various Restrictions) (Variation No.11) Order 2010 ("the 2005 Order"), is amended in the manner and to the extent specified in the Schedule to this Order.


