

**OXFORDSHIRE COUNTY COUNCIL
(HEADINGTON NORTH EAST) (CONTROLLED PARKING ZONE
AND WAITING RESTRICTIONS) (VARIATION NO.9) ORDER 2011**

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 32, 35, 45, 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, makes the following Order:

1. This Order may be cited as the Oxfordshire County (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.9) Order 2011 and shall come into operation on the 7th day of March 2011.
2.
 - (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
 - (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
 - (3) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
 - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.
3. The Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) Order 2006 as amended by the Oxfordshire County Council (Headington Quarry, Girdlestone Road, Headington and Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) Order 2007; the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.2) Order 2008, the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.3) Order 2003, the Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2002 - Consequential Provisions) Order 2008 and the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.5) Order 2008 the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.6) Order 2009, the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.7) Order 2009, and the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.8) Order 2010 ("the 2006 Order"), is amended in the manner and to the extent specified in the Schedule to this Order.

Amendments to "the 2006 Order":

1.

In Schedule 4 Part B - Permit Holders Parking Places
9.00 Am – 5.00 Pm Monday to Friday.

Item 13 is deleted and replaced as follows:

- "13 Northfield Road
- a) South side: From a point 4.7 metres west of the western kerb line of Northfield Road westwards for a distance of 14 metres
 - b) South side: From a point 3.5 metres west of the common boundary of numbers 21 and 23 Northfield Road, eastwards for a distance of 28 metres.
 - c) South side: From a point 22 metres west of the common boundary of numbers 21 and 23 Northfield Road, westwards for a distance of 36 metres.
 - d) West side: From a point 6.5 metres north of the common boundary of numbers 17 and 19 Northfield Road, southwards for a distance of 41 metres.
 - e) East side: From a point 10.5 metres north of the common boundary of numbers 6 and 8 Northfield Road, southwards for a distance of 56 metres."
