THE OXFORDSHIRE COUNTY COUNCIL (EAST OXFORD) (CONTROLLED PARKING ZONE, WAITING RESTRICTIONS AND TRAFFIC MANAGEMENT) (VARIATION No.4) ORDER 2011

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 32, 35, 45 & 46 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

- This Order may be cited as the Oxfordshire County Council (East Oxford) (Controlled Parking Zone, Waiting Restrictions and Traffic Management) (Variation No.4) Order 2011 and shall come into force on the 31st day of October 2011.
- (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.
 - (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.
 - (3) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
 - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.
- 3. The Oxfordshire County Council (East Oxford) (Controlled Parking Zone) Order 2010, as amended by the Oxfordshire County Council (East Oxford) (Controlled Parking Zone, Waiting Restrictions and Traffic Management) (Variation No.1) Order 2010; the Oxfordshire County Council (East Oxford) (Controlled Parking Zone, Waiting Restrictions and Traffic Management) (Variation No.2) Order 2011; and the Oxfordshire County Council (East Oxford) (Controlled Parking Zone, Waiting Restrictions and Traffic Management) (Variation No.3) Order 2011 ("the 2010 Order") is amended in the manner and to the extent specified in the Schedule to this Order.
