OXFORDSHIRE COUNTY COUNCIL (PAY & DISPLAY PARKING OXFORD CITY) (VARIATION NO.5) ORDER 2012

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1, 2, 4,, and 45 to 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, make the following Order:

- This Order may be cited as the Oxfordshire County Council (Pay & Display Parking Oxford City) (Variation No.5) Order 2012 and shall come into operation on the 23rd day of July 2012.
- 2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
- 3. The Oxfordshire County Council (Pay & Display Parking, Oxford City) Order 2002 as amended by the Oxfordshire County Council (City of Oxford and North Hinksey Traffic Management Act 2004) (Consequential Provisions) Order 2008, the Oxfordshire County Council (Pay & Display Parking, Oxford City) (Variation No 2) Order 2009, and subject to variation of charges made by notices of 4 November 2005, 13 December 2006 and 19 August 2010 pursuant to Section 46A of the Act, the Oxfordshire County Council (Pay & Display Parking Oxford City) (Variation No.3) Order 2011, and the Oxfordshire County Council (Pay & Display Parking Oxford City) (Variation No.4) Order 2012 ("the 2002 Order") is amended in the manner and to the extent specified in the Schedule to this Order

"FIRST SCHEDULE

DESIGNATED PARKING PLACES

PART I (CHARGING HOURS 8.00am - 6.30pm MONDAYS to FRIDAYS and 8.00am - 1.00pm SATURDAYS)

1. BENSON PLACE

- (a) Southern side; from a point 44 metres east of the eastern kerb line of Fyfield Road, westwards to Norham Road.
- (b) Eastern side; from a point opposite the northern boundary of number 4, southwards for a distance of 20 metres.
- (c) Eastern side; from the northern property boundary of The Cottage, southwards for a distance of 10 metres.

2. BRADMORE ROAD

- (a) Eastern side; from a point 20 metres north of the northern kerb line of Norham Gardens, northwards for a distance of 50 metres.
- (b) Eastern side; from a point 69 metres north of the northern kerb line of Norham Gardens, northwards for a distance of 18 metres.
- (c) Western side; from a point 57 metres north of the northern kerb line of Norham Gardens, northwards for a distance of 18 metres.
- (d) Western side; from a point 89 metres north of the northern kerb line of Norham Gardens, northwards for a distance of 18 metres.
- (e) Western side; from a point 28 metres north of the northern kerb line of Norham Gardens, southwards for a distance of 28 metres.

3. CRICK ROAD

- (a) Southern side; from a point 15 metres east of the eastern kerb line of Bradmore Road, eastwards for a distance of 34 metres.
- (b) Southern side; from a point 54 metres east of the eastern kerb line of Bradmore Road, eastwards for a distance of 19 metres.

- (c) Southern side; from a point 14 metres west of the western kerb line of Fyfield Road, westwards for a distance of 37 metres.
- (d) Northern side; from a point 15 metres east of the eastern kerb line of Bradmore Road, eastwards for a distance of 57 metres.

4. FYFIELD ROAD

- (a) Eastern side; from a point 36 metres north of the northern kerb line of Norham Gardens, northwards for a distance of 71 metres.
- (b) Eastern side; from a point 57 metres north of the northern kerb line of Norham Gardens, northwards for a distance of 20 metres.

5. NORHAM ROAD

- (a) Northern side; from a point 25 metres east of the eastern kerb line of Banbury Road, eastwards for a distance of 71 metres.
- (b) Northern side; from a point 42 metres west of the western property boundary of number 11 Norham Road, eastwards for a distance of 30 metres.
- (c) Southern side; from a point 24 metres east of the eastern kerb line of Banbury Road, eastwards for a distance of 42 metres.
- (d) Southern side; from a point 14 metres east of the eastern kerb line of Fyfield Road, eastwards to Benson Place.

PART II (CHARGING HOURS 8.00am - 10.00pm MONDAY to SATURDAY and 10.00am - 10.00pm SUNDAY)

GREAT CLARENDON STREET

- (a) South-eastern side; from a point 10 metres south-west of the south-western kerb line of Walton Street, south-westwards for a distance of 115 metres.
- (b) North-western side; from a point 30 metres south-west of the south-western kerb line of Walton Street, south-westwards for a distance of 85 metres.

2. WALTON STREET

(a) South-western side; from a point 98 metres northwest of the north-western kerb line of Walton Crescent, north-westwards for a distance of 27 metres.

- (b) North-eastern side; from a point 117 metres southeast of the south-eastern kerb line of Observatory Street, south-eastwards for a distance of 46 metres.
- (c) North-eastern side; from a point 170 metres southeast of the south-eastern kerb line of Observatory Street, south-eastwards for a distance of 20 metres.
- (d) North-eastern side; from a point 220 metres southeast of the southeastern kerb line of Observatory Street, south-eastwards for a distance of 15 metres.

PART III (CHARGING HOURS 8.00am - 10.00pm MONDAY to SATURDAY and 10.00am - 10.00pm SUNDAY)

NORHAM GARDENS

- (a) North-western side; from a point 22 metres south-west of the western kerb line of Bradmore Road, south-westwards for a distance of 85 metres.
- (b) Northern side; from a point 20 metres east of the eastern kerb line of Bradmore Road, eastwards for a distance of 16.5 metres.
- (c) Northern side; from a point 10 metres east of the eastern kerb line of Fyfield Road, eastwards for a distance of 15 metres.
- (d) Southern side; from a point 22 metres east of the point opposite the eastern kerb line of Bradmore Road, eastwards for a distance of 25 metres.
- (e) Southern side; from a point 9 metres east of the property boundary between numbers 11 and 13 Norham Gardens, eastwards for a distance of 62 metres.
- (f) Southern side; from a point 15 metres east of the property boundary between numbers 15 and 17 Norham Gardens, eastwards for a distance of 33 metres.
- (g) Southern side; from a point 8 metres east of the point opposite the eastern kerb line of Fyfield Road, eastwards for a distance of 16 metres."
