THE OXFORDSHIRE COUNTY COUNCIL (VARIOUS STREETS EAST OXFORD) (TRAFFIC REGULATION) (VARIATION No.10) ORDER 2012

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2 (1) & (2) and 32(1) of the Road Traffic Regulation Act 1984 ("the Act of 1984") and Part IV of Schedule 9 to the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 and of all other enabling powers make the following Order:

- This order shall be cited as the Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) (Variation No.8) Order 2012 and shall come into force on the 29th day of October 2012.
- (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.
- 3. The Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) Order 2002 as amended by the Oxfordshire County Council (Cowley Road, Oxford) (Traffic Regulation) Order 2005, the Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) (Variation No.1) Order 2007, the Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2004 - Consequential Provisions) Order 2008; the Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) (Variation No.4) Order 2009; and the Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) (Variation No.5) Order 2009, the Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) (Variation No.6) Order 2009, the Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) (Variation No.7) Order 2009, the Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) (Variation No.8) Order 2012 and the Oxfordshire County Council (Various Streets East Oxford) (Traffic Regulation) (Variation No.9) Order 2012 ("the 2002 Order") shall be amended in the manner and to the extent specified in the Schedule to this Order.
