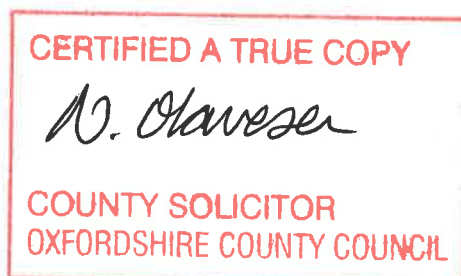


**OXFORDSHIRE COUNTY COUNCIL  
(VARIOUS STREETS, NORTH HINKSEY)  
(WAITING RESTRICTIONS) (VARIATION NO.2) ORDER 2013**

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1 (1), 2 (1) & (2) and 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Various Streets, North Hinksey) (Waiting Restrictions) (Variation No.2) Order 2013 and shall come into force on the first day of July 2013.
2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment  
  
(2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa  
  
(3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment  
  
(4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.
3. The Oxfordshire County Council (Various Streets, North Hinksey) (Waiting Restrictions) Order 2009, as amended by the Oxfordshire County Council (Various Streets, North Hinksey) (Waiting Restrictions) (Variation No.1) Order 2013 ("the 2009 Order") is amended in the manner and to the extent specified in the Schedule to this Order.

## SCHEDULE

1.

In the articles to the 2009 Order the following amendment is made:

Within the definition of "Prescribed Hours" item (d) "Schedule 4, between 8.00am and 5.00pm on Mondays to Fridays inclusive" is deleted.

2.

SCHEDULE 1 to the 2009 Order is deleted and replaced as follows:

### **"SCHEDULE 1**

#### **NO WAITING AT ANY TIME**

1. **ARTHRAY ROAD**

(a) north side

- (i) from its junction with Westminster Way, westwards for a distance of 47 metres;
- (ii) from a point 17 metres west of its junction with Church Way eastwards for a distance of 78 metres;

(b) south side - from its junction with Westminster Way, westwards to a point 54 metres west of its junction with Finmore Road.

2. **CHAPEL WAY**

(a) north and east side, from its junction with Westminster Way westward and northward for a distance of 130 metres;

(b) south and west side

- (i) from its junction with Westminster Way westwards for a distance of 55 metres;
- (ii) from a point 65 metres west of its junction with Westminster Way northward for a distance of 73 metres.

3. **CHURCH WAY**

both sides

- (i) from its junction with Arthray Road northward for a distance of 43 metres;
- (ii) from its junction with West way southward for a distance of 66 metres.

4. **CRABTREE ROAD**

both sides, from its junction with Montagu Road southward for a distance of 33 metres.

5. **ELMS PARADE**

- (a) both sides, from its junction with Church Way eastward for a distance of 4 metres;
- (b) the south side, from its junction with Chapel Way westward for a distance of 6 metres.

6. **FINMORE ROAD**

- (a) both sides, from its junction with Montagu Road northward for a distance of 42 metres;

- (b) the east side, from its junction with Arthray Road southward for a distance of 72 metres;
- (c) the west side, from its junction with Arthray Road southward for a distance of 34 metres.

7. MONTAGU ROAD

both sides, from a point 23 metres east of its junctions with Finmore Road and Crabtree Road westward for a distance of 53 metres.

8. NORTH HINKSEY LANE

- (a) both sides of that length running southeast from its junction with West Way, west of the McDonalds Restaurant,
  - (i) from its junction with West Way southward for a distance of 20 metres;
  - (ii) from a point 154 metres southeast of its junction with West Way south-eastwards for a distance of 100 metres;
- (b) both sides of that length running southwest from its junction with West Way, east of the McDonalds Restaurant, from its junction with West Way south-westward for a distance of 16 metres;
- (c) both sides, from a point approximately 18.3 metres northwest of the Cemetery entrance to a point 91.5 metres southeast of the Cemetery entrance.

9. POPLAR ROAD

both sides, from its junction with West Way northward for a distance of 46 metres.

10. SEACOURT ROAD

both sides, from its junction with Poplar Road westward for a distance of 68 metres.

11. WEST WAY

- (a) both sides, from Botley River Bridge to a point 38 metres east of its junction with Westminster Way;
- (b) south side, from its junction with Eynsham Road (B4044) to a point 38 metres east of its junction with Westminster Way.


12. WESTMINSTER WAY

- both sides
  - (a) from its junction with West Way southward for a distance of 212 metres;
  - (b) from a point 76 metres north of the centre line of Montagu Road southwards for a distance of 138 metres."

Schedule 4 to the 2009 Order "No Waiting between 8.00am to 500pm on Mondays to Fridays inclusive" is deleted.
