THE OXFORDSHIRE COUNTY COUNCIL (GIRDLESTONE ROAD) (CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS) (VARIATION NO.5) ORDER 2014

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order:

- 1. This Order may be cited as The Oxfordshire County Council (Girdlestone Road) (Controlled Parking Zone and Waiting Restrictions) (Variation No.5) Order 2014 shall come into operation on the 21st day of March 2014.
- 2. (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
 - (4) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
 - (5) Any reference in this Order to a numbered Article shall unless the context otherwise requires be construed as a reference to the numbered Article bearing that number in this Order.
- 3. The Oxfordshire County Council (Girdlestone Road) (Controlled Parking Zone and Waiting Restrictions) Order 2006, as amended by The Oxfordshire County Council (Headington Quarry, Girdlestone Road, Headington and Headington North East) (Controlled Parking Zone and Waiting Restrictions) (Variation) Order 2007, The Oxfordshire County Council (Girdlestone Road) (Controlled Parking Zone and Waiting Restrictions) (Variation No.2) Order 2007, The Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2004 Consequential Provisions) Order 2008, and The Oxfordshire County Council (City of Oxford) (Variation of Charges for Residents Permits) Order 2010 ("the 2006 Order") is amended in the manner and to the extent specified in the schedule to this order.
