

**OXFORDSHIRE COUNTY COUNCIL  
(NORTH OXFORD)  
(CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS)  
(VARIATION No.7) ORDER 2014**

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) & (2), 4, 32, 35, 45 & 46 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

1. This Order may be cited as the Oxfordshire County Council (North Oxford) (Controlled Parking Zone and Waiting Restrictions) (Variation No.7) Order 2014 and shall come into operation on the 28<sup>th</sup> day of July 2014.
2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.  
  
(2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.  
  
(3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.  
  
(4) Any reference in this Order to a numbered Article or Schedule shall, unless the context otherwise requires, be construed as a reference to a numbered Article or Schedule bearing that number in this Order.
3. The Oxfordshire County Council (North Oxford) (Controlled Parking Zone and Waiting Restrictions) Order 2004 as amended by the Oxfordshire County Council (North Oxford) (Controlled Parking Zone and Waiting Restrictions) (Variation No.1) Order 2007, the Oxfordshire County Council (North Oxford) (Controlled Parking Zone and Waiting Restrictions) (Variation No.2) Order 2008, the Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2004 - Consequential Provisions) Order 2008, the Oxfordshire County Council (North Oxford) (Controlled Parking Zone and Waiting Restrictions) (Variation No.4) Order 2010, the Oxfordshire County Council (Controlled Parking Zone and Waiting Restrictions) (Variation No. 5) Order 2011, and the Oxfordshire County Council (Controlled Parking Zone and Waiting Restrictions) (Variation No. 6) Order 2012 ("the 2004 Order") shall be amended in the manner and to the extent specified in the Schedule to this Order.


