

**OXFORDSHIRE COUNTY COUNCIL**  
**(DISABLED PERSONS PARKING PLACES - OXFORD)**  
**(VARIATION NO.8) ORDER 2015**

The Oxfordshire County Council ("the Council") in exercise of its powers contained in Sections 1(1), 2(2), 32, 35 and 45 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) (Variation No.8) Order 2015 and shall come into force on the 24<sup>th</sup> day of April 2015.
2.
  - (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
  - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
  - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.

The Oxfordshire County Council (Disabled Persons Parking Places - Oxford) Order 2010, as amended by the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) (Variation No.1) Order 2011, the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) (Variation No.2) Order 2011, the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) (Variation No.3) Order 2012, the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) (Variation No.4) Order 2012, the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) (Variation No.5) Order 2012, the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) (Variation No.6) Order 2013, and the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) (Variation No.7) Order 2014, ("the 2010 Order") is amended in the manner and to the extent specified in the schedule to this order.

		(e)	Northern kerb line of St. John's Terrace; from a point 7.7 metres west of the eastern kerb line of St Giles' northwards for a distance of 7.6 metres, parking at right-angles to the main carriageway of St Giles' for a distance of 4.6 metres westwards.
33	St. John Street	(a)	Western side; from a point 70 metres north of the northern kerb line of Beaumont Street, northwards for a distance of 9 metres, outside No 58 St. John Street.
34	St. Michaels Street	(a)	Northern side; from a point 25 metres east of the western flank wall of No.36 St Michael's Street eastwards for a distance of 13 metres.

		(b)	Northern side; from a point 54 metres east of the western flank wall of No.36 St Michael's Street eastwards for a distance of 25 metres.
35	St Thomas Street		North side; from the eastern end of the arched access to the rear of St Peter's College annexe, eastwards for a distance of 6.6 metres. Outside St Peter's College annex.
36	Walton Street	(a)	East side; from a point 31 metres south-west of the south-western kerb line of Little Clarendon Street, southwards for a distance of 6.6 metres.
		(b)	North-eastern side; from a point 60 metres south-east of the south-eastern kerb line of Observatory Street, south-eastwards for a distance of 30 metres.
37	Wellington Square		Southern side; from a point 27 metres west of the eastern kerb line, westwards for a distance of 10 metres, outside Rewley House.
38	Wellington Street	(a)	North-west side; from a point 8 metres north-east of the north-eastern kerb line of Albert Street, north-eastwards for a distance of 6 metres. Outside 48 Wellington Street.
		(b)	South-east side; from a point 66 metres north-east of the north-eastern kerb line of Nelson Street, north-eastwards for a distance of 6 metres. Opposite No 45 Wellington Street.
39	Worcester Place		North side; from a point 17 metres west of the western kerb line of Walton Street, westwards for a distance of 18 metres."
